AN **ORDINANCE** AMENDING **ORDINANCE** NUMBER 14-08, CHAPTER 1216, THE UNIFIED DEVELOPMENT ORDINANCE, AS AMENDED, TO REZONE 2.0 ACRES OF LAND, MORE OR LESS, LOCATED AT CORNERSTONE OF CENTERVILLE NORTH, PHASE IV, FROM B-PD, BUSINESS PLANNED DEVELOPMENT WITH CC, COMMUNITY CENTER OVERLAY ZONE CLASSIFICATION, TO B-PD. BUSINESS PLANNED DEVELOPMENT WITH NC, NEIGHBORHOOD CLASSIFICATION CENTER OVERLAY ZONE CLASSIFICATION.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. The Official Zoning Map attached to Ordinance Number 14-08, Chapter 1216, Article 7 of the Unified Development Ordinance, passed on the 15th day of December, 2008, and as subsequently amended, be, and the same hereby is amended to rezone 2.0 acres of land, more or less, located at Cornerstone of Centerville North, Phase IV from B-PD, Business Planned Development zone classification with CC, Community Center Overlay, to B-PD, Business Planned Development with NC, Neighborhood Center zone classification. A map and legal description defining the area is marked Exhibit "A", attached hereto and incorporated herein. The Parcel Identification Number is currently a portion of L49000100010000200.

<u>Section 2.</u> The zoning map of the City of Centerville, Ohio, shall be revised to reflect these adjustments.

<u>Section 3.</u> This ordinance shall take effect and be in force at the earliest date provided by law.



THENCE, NORTHEASTERLY, 45.10 FEET, ALONG THE SOUTHERLY RIGHT OF WAY LINE OF CORNERSTONE NORTH BOULDEVARD AND THE ARC OF A CURVE TO THE RIGHT HAVING A RADIUS OF 287.00 FEET, AN INTERNAL ANGLE OF 09°00'16" AND A CHORD 45.06 FEET IN LENGTH BEARING NORTH 86°51'57" EAST, TO A POINT OF TANGENCY;
