CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER John Beals ON THE 20<sup>th</sup> DAY OF August, 2018.

**AN ORDINANCE TO ADOPT SECTION 210.17,  
PARTICIPATION IN NATIONAL OR STATE  
PURCHASING PROGRAMS.**

**WHEREAS**, Ohio Revised Code Section 9.48 allows political subdivisions to participate in joint purchasing programs operated by or through a national or state association of political subdivision in which the purchasing political subdivision is eligible for membership; and

**WHEREAS**, Article VII, Section 7.07 of the Charter of the City of Centerville sets forth the Contracting Procedure for the City of Centerville; and

**WHEREAS**, City Council by ordinance may set forth the Contracts and Purchasing authority of the City; and

**WHEREAS**, Chapter 210 of the Centerville Municipal Code establishes competitive bidding procedures for the purchase of supplies, materials, and labor for the City of Centerville; and

**WHEREAS**, the City desires to participate in joint purchasing programs operated by or through national or state associations in lieu of the local bidding procedures where warranted.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. That the following Section 210.17 of the Centerville Municipal Code is hereby adopted and enacted as follows:

**210.17 PARTICIPATION IN NATIONAL OR STATE PURCHASING PROGRAMS.**

Upon authorization by the Manager and approval by the City Council, the Purchasing Agent shall be permitted to participate in a joint purchasing program operated by or through a national or state association of political

subdivisions in which the City of Centerville is eligible for membership. Participation through this cooperative purchasing process may be utilized in lieu of the City of Centerville's local bidding procedures.

Section 2. This ordinance shall become effective from and after the earliest date allowed by law.
