AN ORDINANCE AMENDING ORDINANCE NUMBER 14-08, CHAPTER 1216, THE UNIFIED DEVELOPMENT ORDINANCE, AS AMENDED. TO REZONE 14.771 ACRES OF LAND, MORE OR LOCATED AT CORNERSTONE OF CENTERVILLE NORTH, PHASE III, FROM B-PD. BUSINESS PLANNED DEVELOPMENT WITH CC, COMMUNITY CENTER OVERLAY ZONE CLASSIFICATION. TO B-PD. BUSINESS PLANNED DEVELOPMENT CLASSIFICATION.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

The Official Zoning Map attached to Ordinance Number 14-08, Chapter 1216, Article 7 of the Unified Development Ordinance, passed on the 15th day of December, 2008, and as subsequently amended, be, and the same hereby is amended to rezone 14.771 acres of land, more or less, located at Cornerstone of Centerville North, Phase III from B-PD, Business Planned Development zone classification with CC, Community Center Overlay, to B-PD, Business Planned Development zone classification. A map and legal description defining the area is marked Exhibit "A", attached hereto and incorporated herein. The Parcel Identification Number is L49000100010000200.

Section 2. The zoning map of the City of Centerville, Ohio, shall be revised to reflect these adjustments.

Section 3. This ordinance shall take effect and be in force at the earliest date provided by law.


