## ORDINANCE NO. 10-12CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER Paul Thesham ON THE 17th 

> AN ORDINANCE AMENDING ORDINANCE NUMBER 14-08, CHAPTER 1216, THE UNIFIED DEVELOPMENT ORDINANCE AS AMENDED, TO REZONE 63.939 ACRES OF LAND, MORE OR LESS, LOCATED NORTH OF SOCIAL ROW ROAD, WEST OF SHEEHAN ROAD AND EAST OF PARAGON ROAD FROM SINGLE-FAMILY RESIDENTIAL WITH RESIDENTIAL OVERLAY ZONE NEIGHBORHOOD OFFICE PLANNED TO O-PD, CLASSIFICATION, DEVELOPMENT WITH A NC, NEIGHBORHOOD CENTER OVERLAY ZONE CLASSIFICATION IN THE SOUTHERN 25.426 ACRES; AND TO R-PD, RESIDENTIAL PLANNED DEVELOPMENT WITH A NR, NEIGHBORHOOD RESIDENTIAL OVERLAY ZONE CLASSIFICATION IN THE NORTHERN 38.514 ACRES.

## THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

The Official Zoning Map attached to Ordinance Number 14-08, Section 1. Chapter 1216, Article 7 of the Unified Development Ordinance, passed on the 15th day of December, 2008, and as subsequently amended, be, and the same hereby is amended to rezone 63.94 acres of land, more or less, located north of Social Row Road, west of Sheehan Road and east of Paragon Road from R-1c, Single-Family Residential with a NR, Neighborhood Residential Overlay zone classification, to O-PD, office planned development with a NC, Neighborhood Center Overlay zone classification in the Southern 25.426 acres; and to R-PD, Residential Planned Development with a NR, Neighborhood Residential Overlay zone classification in the northern 38.514 acres District zone classification. A map defining the area is marked Exhibit "A", attached hereto and incorporated herein. Included is Parcel Identification number O68 01119 0007.

The zoning map of the City of Centerville, Ohio, shall be revised to reflect Section 2. these adjustments.

This ordinance shall be effective at the earliest date allowed by law. Section 3.
