AN EMERGENCY ORDINANCE TO AMEND SUBSECTION C TO ATTACHMENT A OF
ORDINANCE NUMBER 25-08, ESTABLISHING CLASS TITLES, PAY RANGES,
GRADES, RATES OF PAY, AND REGULATIONS FOR EMPLOYEES OF THE CITY OF
CENTERVILLE, OHIO.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. Subsection C to Attachment A of Ordinance Number 25-08 is hereby amended with the bracketed portions deleted and the italicized portions added.

Attachment A

C. Classified Year-Round Employees Class III

All employees in Class III shall be paid within the designated pay range. Ranges will be automatically adjusted based upon the annual wage adjustment. Each employee shall receive an annual evaluation and will be eligible for a merit step increase once per year, based upon the attached pay scale.




