**AN EMERGENCY ORDINANCE AMENDING  
SECTION 224.01 OF THE CENTERVILLE  
MUNICIPAL CODE FOR THE LISTING OF  
THE POSTING PLACES FOR ORDINANCES AND  
RESOLUTIONS WITHIN THE CITY PER THE  
CITY CHARTER.**

**WHEREAS**, Article V of the Charter for the City of Centerville sets forth the requirements for introduction and passage of ordinances and resolutions; and

**WHEREAS**, Section 5.03 of the Charter for the City of Centerville requires for publication of new ordinances to either be the printing in summary form in one or more newspapers of general circulation in the Municipality and/or to post in full in not less than five (5) of the most public places in the Municipality as determined by Council; and

**WHEREAS**, Council has by Ordinance previously determine those five most public places; and

**WHEREAS**, Council finds it necessary to update those places due to one of the locations being closed;

**NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:**

Section 1. That the following amendments to Section 224.01 of the Centerville Municipal Code are hereby enacted as follows with new language to be added in *italics* and text to be deleted in ~~strikeout~~ as provided in Section 5.02 of the Centerville Charter:

**224.01 POSTING PLACES.**

All ordinances and resolutions, and any statements, orders, proclamations, notices or reports required by law or ordinance, or by the City Charter, to be published, shall be published by posting copies thereof for the required period of time in each case in the following places, which are hereby determined to be five of the most public places in the Municipality:



Posting shall be made in a conspicuous place in such buildings and such places shall be readily accessible to all members of the public at reasonable hours.

Section 2. This Ordinance is hereby declared to be an emergency measure and shall become effective immediately upon passage. An emergency affecting public health, safety and welfare is hereby declared to exist by virtue of the fact that the City Charter requires posting in five locations and one of the locations no longer exists, thus making it difficult to publish future ordinances.
