ORDINANCE NO. <u>10-06</u>

AN ORDINANCE AMENDING CHAPTER 1611, CENTERVILLE MUNICIPAL CODE BY ADOPTING THE 2005 SOUTHWEST OHIO FIRE SAFETY COUNCIL UNIFIED STANDARDS IN LIEU OF THE 1994 EDITION THEREOF BY REFERENCE.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. That Section 1611.01, Centerville Municipal Code, is hereby amended as follows with the deleted portion shown by strikeout and the new portion by *italics*:

Pursuant to Section 5.06 of the Centerville Charter, there is hereby adopted as new Chapter 1611 and incorporated by reference as if set out at length herein for the purpose of prescribing regulations for the safeguarding, to a reasonable degree, of life and property from the hazards of fire and explosion arising from the storage, handling and use of hazardous substances, materials and devices and from conditions hazardous to life or property in the use or occupancy of buildings or premises, that certain Code known as the 1999 Edition of the Unified Fire Code consisting of the Boca National Fire Prevention Code (1993 Edition) as published by the Building Officials and Code Administrators International, Inc. and the amendments contained therein from the Southwest Fire Safety Council Standards (1994) 2005 Southwest Ohio Fire Safety Council Unified Standards.

Section 2. As used in the 2005 Southwest Ohio Fire Safety Council Unified Standards, the following terms shall have the following meanings:

- A. "Governing body" means the Council of the City of Centerville, Ohio.
- B. "Jurisdiction" means the City of Centerville, Ohio.
- C. "Fire chief" means the Chief of the Fire Division.

<u>Section</u> 3. This Ordinance shall become effective from and after the earliest date allowed by law.
