AN ORDINANCE AUTHORIZING THE ANNEXATION OF CONTIGUOUS TERRITORY OWNED BY THE CITY OF CENTERVILLE AND DIRECTING THE MUNICIPAL ATTORNEY TO PROSECUTE THE PROCEEDINGS NECESSARY TO EFFECT SAID ANNEXATION.

WHEREAS, the City of Centerville is the owner of two tracts of land, being a 0.161acre tract and a 0.137 acre tract which are located in the unincorporated area of Washington Township, Montgomery County, Ohio but contiguous to the corporate limits of the City which tracts are more particularly described in Exhibit A, attached hereto and incorporated herein; and

WHEREAS, the Council proposes to annex said property to the City of Centerville in accordance with the provisions of §709.14 et. seq. Ohio Revised Code.

NOW, THEREFORE,

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. That the annexation of the city owned property described in Exhibit A is hereby authorized and the Municipal Attorney is hereby directed to prosecute the proceedings necessary to effect said annexation.

Section 2. This ordinance shall become effective from and after the earliest date allowed by law.

thence departing said centerline, and with said corporation line. South 89°32'47" West.


