## ORDINANCE NO. 14-00 CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER James Singer ON THE 21st DAY OF August, 2000

AN EMERGENCY ORDINANCE AUTHORIZING THE ANNEXATION OF CONTIGUOUS TERRITORY AND DIRECTING THE MUNICIPAL ATTORNEY TO PROSECUTE THE PROCEEDINGS NECESSARY TO EFFECT SAID ANNEXATION.

WHEREAS, the City of Centerville is the owner of a 0.265 acre tract which is located in the unincorporated area of Washington Township, Montgomery County, Ohio but contiguous to the corporate limits of the City which tract is more particularly described in Exhibit A, attached hereto and incorporated herein; and

WHEREAS, the Council proposes to annex said property to the City of Centerville in accordance with the provisions of §709.14 et. seq. Ohio Revised Code.

NOW, THEREFORE,

## THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. That the annexation of the city owned property described in Exhibit A is hereby authorized and the Municipal Attorney is hereby directed to prosecute the proceedings necessary to effect said annexation.

Section 2. This ordinance is hereby declared to be an emergency and shall become effective upon passage. An emergency affecting public health and safety is hereby declared to exist by virtue of the fact that it is likely that the General Assembly will pass new legislation that will discontinue this method of annexation.


