ORDINANCE NO. <u>5-97</u> CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER JAMES SINGER ON THE 19th DAY OF 14A4 , 1997.

AN ORDINANCE ESTABLISHING A PROCEDURE FOR COMPETITIVE BIDDING FOR PUBLIC CONTRACTS BY DESIGNATING THE WEDNESDAY EDITION OF THE CENTERVILLE-BELLBROOK TIMES AS A NEWSPAPER OF GENERAL CIRCULATION.

WHEREAS, § 7.12, Ohio Revised Code defines a "newspaper of general circulation," inter alia, as a newspaper "...regularly issued as frequently as once a week for a definite price or consideration paid for by not less than fifty per cent of those to whom distribution is made..."; and

WHEREAS, the Wednesday edition of the Centerville-Bellbrook Times is issued without charge to those to whom it is distributed which disqualifies it as a newspaper of general circulation pursuant to § 7.12, Ohio Revised Code; and

WHEREAS, the City of Centerville is a chartered municipality, exercising the full range of home rule powers and powers of local self-government in accordance with Article XVII, Sections 3 and 7 of the Constitution of the State of Ohio; and

WHEREAS, the procedure for public bidding is a power of local self government which would allow the City of Centerville to depart from the requirements of said § 7.12, Ohio Revised Code and designate the Wednesday edition of the Centerville-Bellbrook Times as a newspaper of general circulation for the purposes of competitive bidding for the City of Centerville which this Council finds would be in the best interests of the citizens of Centerville;

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. That the Wednesday edition of the Centerville-Bellbrook Times is hereby designated as a newspaper of general circulation for public bidding purposes for the City of Centerville.

Section 2. This ordinance shall become effective from and after the earliest date allowed by law.
