18<sup>th</sup> DAY OF AUGUST, 1997.

AN ORDINANCE AMENDING THE CENTERVILLE  
MUNICIPAL CODE BY PROVIDING ADDITIONAL  
REGULATIONS RELATING TO BUILDINGS.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. Definition: As used herein, the following terms are defined as:

(1) *Live Entertainment Occupancies: A building, structure or occupancy where there are performances of dancing, singing, nudity or semi-nudity as part of the entertainment, or nudity or semi-nudity in connection with food and/or beverage service by waiters or waitresses. A Live Entertainment Occupancy shall not include a building, structure or occupancy where the entertainment is supplied solely by the patrons who are neither nude nor semi-nude.*

(2) *Nudity: The appearance of a human bare buttock, anus, male genitals, female genitals, or female breast; or a state of dress which fails to opaquely cover a human buttock, anus, male genitals, female genitals, or areola of the female breast.*

(3) *Semi-nudity: A state of dress in which clothing covers no more than the genitals, pubic region, and areola of the female breast, as well as portions of the body covered by supporting straps or devices.*

Section 2. That Section 1486.05 of the Centerville Municipal Code is hereby amended by adding the following which appears in italics:

**1486.05 Light.**


(a) Required. All spaces or rooms shall be provided with sufficient light so as not to endanger health and safety.

*(1) Live Entertainment Occupancies. In places of Live Entertainment Occupancies, other than municipal, township, state or federal government buildings, adequate lighting with an illumination of at least a sixty-watt standard incandescent light bulb or*


*equivalent for each 200 square feet (18.60 square meters) of floor area and spacing between lights of not greater than twenty feet shall be operable and in use at all times during the presence of human beings and said illumination shall in any event produce a minimum of one (1) foot candle of lighting at floor level.*

Section 3. This Ordinance shall become effective from and after the earliest date allowed by law.
