CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER JAMES REPERT ON THE
15th DAY OF SEPTEMBER, 1997.

AN EMERGENCY ORDINANCE TO AMEND
ORDINANCE NUMBER 20-96, TO ESTABLISH CLASS
TITLES, PAY RANGES, GRADES, RATES OF PAY, AND
THE REGULATIONS FOR EMPLOYEES OF THE CITY
OF CENTERVILLE, OHIO, THE ITALICIZED PORTIONS
TO BE ADDED.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. "Attachment A., D. Police Employees Class IV" of Ordinance
Number 20-96 is hereby amended with the italicized portions to be added.

D. Police Employees Class IV

All employees in Class IV shall be paid within the designated pay range below. Ranges and individual wages will be automatically adjusted based upon the annual wage adjustment. Each employee shall receive, at a minimum, six month evaluations and will be eligible for a merit step increase once per year, based upon the scale below. Each employee in Class IV is eligible for benefits described in Section 8 herein. The City shall pay 8.5% of the employee's share of retirement contributions to PPF or PERS for all positions listed below.




Section 2. The compensation provided herein shall be effective on October 1, 1997.
