## ORDINANCE NO. <u>(-94</u> CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER <u>MARM KINIGSTED</u> ON THE <u>STL</u> DAY OF <u>MARCH</u>, 1996.

AN ORDINANCE AMENDING ORDINANCE NUMBER 11-86 DATED JULY 21, 1986, THE ZONING ORDINANCE BY REZONING 0.8098 ACRES MORE OR LESS, FROM CENTERVILLE R-PD CLASSIFICATION TO CENTERVILLE O-S CLASSIFICATION.

## THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

<u>Section 1</u>. That the zoning map attached to Ordinance Number 11-86 passed on the 21st day of July, 1986, and as subsequently amended, by, and the same hereby is revised as follows:

By changing the zoning of the following described property from Centerville R-PD classification to Centerville O-S classification:

Situated in Section 14, Town 2, Range 6 MRS, City of Centerville, Montgomery County, State of Ohio, and being part of that land as conveyed to Christ Community Church by the deed recorded on Microfiche #81-005B02 in the deed records of said county and being described more particularly as follows:

Beginning for reference at an iron pin found at the northwest corner of said Section 14, thence with the north line of said Section 14 South 69°00'00" East, 55.00 feet, to the east right-of-way line of Bigger Road and the True Point of Beginning:

Thence continuing with said section line and the north line of said church land South 69°00'00" East, 278.00 feet, to an iron pin set; thence leaving the north line of said section and the north line of said church land along the new division line South 21°00'00" West, 138.48 feet, to an iron pin set in the south line of said church land North 69°00'00" West, 231.47 feet, to a point on the east right-of-way line of Bigger Road; thence with the east right-of-way line of Bigger Road North 02°25'35" East, 146.09 feet, to the True Point of Beginning containing 0.8098 acres more or less subject however to all legal highways, easements, and restrictions of record.

Being the result of a Survey and Plat by Jeffrey A. Van Atta of Van Atta Engineering, Inc., Surveyor No. PS 7354, dated July 27, 1995.
