AN ORDINANCE AMENDING ORDINANCE NUMBER 11-86 DATED JULY 21, 1986, THE ZONING ORDINANCE BY REZONING 4.00 ACRES MORE OR LESS, FROM CENTERVILLE R-1C CLASSIFICATION TO CENTERVILLE R-PD CLASSIFICATION.


THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. That the zoning map attached to Ordinance Number 11-86 passed on the 21st day of July, 1986, and as subsequently amended, by, and the same hereby is revised as follows:

By changing the zoning of the following described property from Centerville R-1C classification to Centerville R-PD classification:

Situated in the City of Centerville, County of Montgomery and State of Ohio and being the Northwest Quarter of Section 14, Town 2, Range 6 MRs, and being a part of the Thirty-seven and Five Tenths (37.5) acre tract conveyed to Rolla Smith as described in Deed Book 911, Page 364, Montgomery County Records, Bounded and described as follows:

Beginning at an iron pin in the center line of the Bigger Road at the Northwest corner of Section 14; thence South 2°30' West with the center line of said road a distance on One Hundred Forty-five and Six Tenths (145.6) feet; thence South 69° East parallel to the North line of Section 14, for a distance of One Thousand Two Hundred Sixty-three (1,263.0) feet; thence North 2°30' East parallel to the center line of the Bigger Road for a distance of One Hundred Forty-five and Six Tenths (145.6) feet to an iron pin on the North line of Section 14; thence North 69° West with the North line of Section 14, for a distance of One Thousand Two Hundred Sixty-three (1,263.0) feet to the place of beginning containing Four (4.0) acres more or less.



Section 3. This Ordinance shall become effective at the earliest date allowed by law.
