AN EMERGENCY ORDINANCE AMENDING ORDINANCE 35-94 ADOPTING INDOOR GOLF ACADEMY FEES AND 1996 GOLF ACADEMY MEMBERSHIP FEES.

The Municipality of Centerville hereby ordains:

Section 1. That Ordinance 35-94 which established the Rules and Regulations for the Golf Club at Yankee Trace is hereby amended by adding the following Indoor Golf Academy fees and 1996 Season Golf Academy Membership Fees as underlined.

## The Golf Club at Yankee Trace Indoor Golf Academy Fee Schedule

\$5.00 per half hour

- attendance at any group clinics offered
- bag storage

\$249.00 for 3 month period

#### Private golf lessons

Each 30 minute lesson \$30,00 Series of four 30 minute lessons \$99.00

## Full Golf Academy Membership for April 1 - October 31, 1996 which includes:

- unlimited use of private practice range, practice putting green, chipping area, greenside and fairway bunkers
- unlimited use of 3-hole practice course
- 10% discount on lesson rates
- 10% discount on all merchandise in the golf shop

- bag storage and lockers at 50% off normal rates

Spouse	\$200.00
Junior (18 and under with adult membership)	\$150.00
Junior (18 and under without adult membership)	\$250.00

### Associate Range Membership for April 1 - October 31, 1996 which includes:

- unlimited use of private range
- ♦ 10% discount on all merchandise purchases in the golf shop
- ♦ bag storage and lockers at 50% off normal rates

Individual membership	\$350.00
Each additional family member	\$150,00
Single junior (18 and under)	\$175.00

# Practice Hole Membership which includes:

Individual	\$200.00
Each additional family member	\$100.00
Single junior (18 and under)	\$150.00

<u>Section 3.</u> The City Manager shall have the authority to adjust the above rates in consultation with City Council.

Section 4. This Ordinance is hereby declared to be an emergency measure and shall become effective immediately upon passage. An emergency affecting public welfare is hereby declared to exist by virtue of the fact that it is essential for the orderly running of the Golf Club at Yankee Trace that Indoor Fees be in effect immediately due to the fact that the indoor facility is currently in operation.
