SECTION 1. That Ordinance No. 12-86 is hereby amended as follows with the underlined portions added and the bracketed portions deleted.

<u>Section 2.</u> <u>Schedule of Fees for the City Landmark</u> <u>Preservation Ordinance</u>

This ordinance shall establish a schedule of fees, charges, and expenses and a collection procedure for applications, variances, appeals, and other matters pertaining to this ordinance.

- <u>A.</u> <u>Application To Designate an Area, Place, Building or</u> <u>Structure as a Landmark - No Fee</u>
- <u>B.</u> <u>Application to Rescind Landmark Designation Five</u> <u>Hundred Dollars</u>
- <u>C.</u> <u>Application to Demolish or Move a Designated Landmark</u> <u>-Three Hundred Dollars</u>
- D. Application Proposing Renovation, Rehabilitation, Remodeling, Addition, Alteration, Development, or Construction of an Area, Place, Building, or Structure Designated as a Landmark - The Fee shall be the same fee as charged for a similar application for

a property located in the City Architectural Preservation Zoning District.
