ORDINANCE NO. 12-88 CITY OF CENTERVILLE, OHIO

DAY OF December, 1988.

AN ORDINANCE VACATING APPROXIMATELY FIVE (5) FEET IN WIDTH OF RIGHT-OF-WAY FROM THE SOUTH SIDE OF EXISTING WHIPP ROAD.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. This Council finds that the sole owner of land in the immediate vicinity of existing Whipp Road has filed its petition with Council praying that such portion of existing Whipp Road as is described in Exhibit A attached hereto and incorporated herein by reference be vacated. The Council has held a public hearing upon said petition and finds that notice provided for in Section 723.07, Ohio Revised Code, is not required by virtue of the provisions of Section 723.06, Ohio Revised Code, because the petitioner has consented to said vacation. Upon said hearing, Council is satisfied that there is good cause for such vacation, that it will not be detrimental to the general interests, and that it should be made.

Section 2. This Council declares that that portion of existing Whipp Road which is described in Exhibit A attached hereto and incorporated herein is hereby vacated.

 $\underline{\text{Section 3}}.$ This Ordinance shall become effective from and after the earliest date allowed by law.

Located in Section 15, Town 2, Range 6, M.R.S., City of Centerville, County of Montgomery, State of Ohio, and being a portion of land conveyed by deed to Finke Realty Company in Deed Microfiche 86-0090B08 of the Deed Records of Montgomery County, Ohio, and being more particularly described as follows:

Beginning at the northeast corner of Oak Creek Four Section Five Record Plan recorded in Plat Book 88, Page 59 of the Plat Records of Montgomery County, Ohio, said corner being in the centerline of Whipp Road; thence along the centerline of Whipp Road, South eighty-five degrees twenty-five minutes twenty seconds (85-25'20") East for three hundred forty-six and 19/100 (346.19) feet; thence South four degrees thirty-four minutes forty seconds (04-34'40") West for twenty-five and 00/100 (25.00) feet to a point in the proposed south right-of-way line of Whipp Road, said point being the TRUE POINT OF BEGINNING of this description;
