AN ORDINANCE TO AMEND ORDINANCE NUMBER 13-68 TO DETERMINE FIVE (5) OF THE MOST PUBLIC PLACES IN THE CITY OF CENTERVILLE FOR PURPOSES OF PUBLISHING NOTICES, ORDINANCES, RESOLUTIONS, PROCLAMATIONS AND REPORTS.

WHEREAS, in accordance with Section 5.03 of the Centerville City Charter, five of the most public places in Centerville were determined by Council by Ordinance Number 13-68 for the purpose of publishing notices, Ordinances, Resolutions, Proclamations and reports; and

WHEREAS, it now becomes necessary that there be determined a replacement for the Centerville Pharmacy for publishing purposes.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

 $\underline{\text{SECTION 1.}}$ That Section 1 of Ordinance Number 13-68 is hereby amended as follows:

Section 1. All Ordinances, Resolutions and any statements, orders, Proclamations, notices or reports required by law or Ordinance, or the Charter of the Municipality of Centerville, Ohio, to be published, shall be published by posting copies thereof for the required period of time in each case in the following places, which are hereby determined to be five (5) of the most public places in the Municipality:

United States Post Office Centerville Branch [203 North Main Street] 99 Maple Avenue Centerville, Ohio

[Centerville Pharmacy 3 North Main Street Centerville, Ohio]

The Siebenthaler Company 6000 Far Hills Avenue Centerville, Ohio

Centerville Municipal Building 100 West Spring Valley Road Centerville, Ohio

The place of posting shall be in a conspicuous place in such buildings and shall be readily accessable to all members of the public at reasonable hours.

SECTION 2. This Ordinance shall become effective from and after the earliest date allowed by law.
