AN ORDINANCE AMENDING ORDINANCE NUMBER 15 DATED DECEMBER 11, 1961, THE ZONING ORDINANCE BY REZONING 63.3 ACRES MORE OR LESS, FROM EC AND I1 CLASSIFICTION TO CENTERVILLE B2 AND R4 CLASSIFICATION.

The municipality of Centerville hereby ordains;

<u>Section I</u>. That the zoning map attached to Ordinance number 15, passed on the 11th day of December, 1961, and as subsequently amended, be, and the same hereby is revised as follows:

of Montgomery County, Ohio; thence South one degree twenty-seven minutes fifty seconds (1° 27' 50") West along said line for a distance of one hundred thirteen and 23/100 (113.23) feet to a

point;

thence continuing along said line on a curve to a left with a radius of one thousand three hundred fortyfive and 44/100 (1,345.44) feet for a distance of three hundred thirty-three and 51/100 (333.51) feet to a point where said line intersects the south line of said Section 20, also being in the centerline of said State Route 725;

thence along the south line of said Section 20 and the centerline of said State Route 725, south eighty-eight degrees three minutes forty seconds (88° 03' 40") West for a distance of four hundred ninety-two and 02/100 (492.02) feet to the point of beginning, containing four and 71/100 (4.71) acres, more or less.
