AN ORDINANCE AMENDING ORDINANCE NO. 15 DATED DECEMBER 11, 1961, THE ZONING ORDINANCE, BY REZONING 16 ACRES, MORE OR LESS, FROM CENTERVILLE ENTRANCE CORRIDOR CLASSIFICATION TO CENTERVILLE B-2 CLASSIFICATION:

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

SECTION 1. That the zoning map attached to Ordinance $\overline{\text{No. 15}}$, passed on the 11th day of December, 1961, and as subsequently amended, be, and the same hereby is, revised as follows:

By changing the zoning of the following described property from Centerville Entrance Corridor Classification to Centerville B-2 Classification:

Located in Section 26, Town 2, Range 6, Miami River Survey, City of Centerville, Montgomery County, Ohio, and being more particularly described as follows:

TRACT 1:

Beginning at a point in the centerline of State Route 48 (coinciding with the westerly corporation line of the City of Centerville) at the north-westerly corner of the Epiphany Lutheran Church property, as recorded in Deed Book 2008, Page 406 (Montgomery County, Ohio, deed records).

Thence, along the north line of said Epiphany Lutheran Church, in an easterly direction a distance of 665.28 feet.

Thence, along the easterly line of said Epiphany Lutheran Church property, in a southerly direction 462 feet.

Thence, along the southerly line of said Epiphany Lutheran Church property, in a westerly direction a distance of 664.62 feet.

Thence along the westerly line of said Epiphany Lutheran Church property in a northerly direction, a distance of 464.64 feet to the point of beginning.

TRACT 2:

Located in Section 26, Town 2, Range 6, Miami River Survey, City of Centerville, Washington Township, Montgomery County, Ohio, and being more particularly described as follows:

Beginning in the westerly corporation line of the City of Centerville, coinciding with the centerline of Route 48, at the intersection with the centerline of Fireside Drive. Thence along the centerline of Route 48, in a northerly direction, a distance of approximately 1,200 feet (passing the centerline of North Village Drive at approximately 1,035 feet).

Thence in an easterly direction, parallel to and 165 feet north of the centerline of North Village Drive, a distance of approximately 410 feet.

Thence along the projected centerline of Fireside Drive, and along the centerline of Fireside Drive iteself in a southerly and then in a westerly direction, an approximate distance of 1,575 feet to the point of beginning.

Combined acreage of the above described two tracts is 16 acres.

SECTION 2. This ordinance shall become effective at the earliest date allowed by law.
