AN ORDINANCE AMENDING SECTION V OF THE CENTERVILLE ADMINISTRATIVE CODE BY PROVIDING FOR WAGES AND HOURS ON PUBLIC WORKS.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

SECTION 1. That Section V of the Centerville Administrative Code is hereby amended by the addition of the following.

5.5 Sections 4115.01 through 4115.16 of the Revised Code of Ohio, as amended from time to time and known as the Prevailing Wage Law, are specifically not incorporated into the ordinances of the City of Centerville. The Council and the various City officers charged with the responsibilities of negotiating, preparing and executing contracts on behalf of the City shall not be bound by any of the provisions of the Prevailing Wage Law, nor shall the City or any of its officers designate a Prevailing Wage Coordinator to perform the various responsibilities specified in the Prevailing Wage Law. Contracts entered into by the City shall not comply with the Prevailing Wage Law unless the Council in its authorizing legislation specifically provides to the contrary or unless as a condition of funding the City is required to so comply.

SECTION 2. This ordinances shall become effective from and after the earliest date allowed by law.
