AN ORDINANCE AMENDING ORDINANCE 15-61, THE ZONING ORDINANCE, SECTION 25 RELATING TO FILING FEES.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. That Ordinance 15-61, The Zoning Ordinance, Section 25 is hereby amended as follows:

FILING FEES. Applications filed pursuant to the provisions of this Ordinance shall be accompanied by the filing fees thereinafter specified.

- A. For each application for a Zoning Certificate the sum of [Five Dollars (\$5.00)] Ten Dollars (\$10.00) for the first One Thousand Dollars (\$1,000.00) of cost for the proposed improvement, plus [One Dollar (\$1.00)] One Dollar Twenty Five Cents (\$1.25) for each additional One Thousand Dollars (\$1,000.00) of cost of the Proposed Development, shall be paid to and collected by the [Mayor or] Administrative Officer, the receipt for which shall accompany the application. The Cost of the Proposed Development shall be based upon Fifteen Dollars (\$15.00) per square foot overall.
- B. For each application for a Certificate of Occupancy as provided for under Section 22K, the sum of [Ten Dollars (\$10.00)] <u>Fifteen Dollars (\$15.00)</u> shall be paid to and collected by the [Mayor or] Administrative Officer, the receipt for which shall accompany the application.
- C. For each application for a variance or appeal, a fee of [Twenty Dollars (\$20.00)] Forty Dollars (\$40.00) shall be paid to and collected by the [Mayor or] Administrative Officer, the receipt for which shall accompany the petition.
- D. For each application for a Conditional Use, a fee of [Fifty Dollars (\$50.00)] <u>One Hundred Fifty Dollars</u> (\$150.00) shall be paid to and collected by the Administrative Officer, the receipt for which shall accompany the petition.
- E. For each petition for an Amendment, Supplement or change to this Ordinance, a fee of [Seventy-Five Dollars (\$75.00)] <u>Two Hundred Twenty-Five Dollars (\$225.00) for each Zoning</u> <u>District Change requested shall be paid to and collected</u> by the Administrative Officer, the receipt for which shall accompany the petition.

Section 2. This Ordinance shall become effective from and after the earliest date allowed by law.
