ON THE 17th DAY OF October, 1977.

AN ORDINANCE DELETING CERTAIN PROPERTY FROM THE IMPROVEMENT DESCRIBED IN RESOLUTION NO. 34-76, DETERMINING TO PROCEED WITH THE REMAINDER OF SAID IMPROVEMENT.

The Municipality of Centerville, Montgomery County, Ohio, hereby ordains:

SECTION 1. That in accordance with the report of the assessment equalization board heretofore appointed, which report has been approved by Resolution of even date herewith, the property located on the East side of North Main Street in the City of Centerville, beginning at the Northwest corner of the Gerber property (Deed Book 2230, page 664), said northwest corner being located approximately 170 feet South of Bradstreet Road, and proceeding thence Southwardly for approximately 724 feet to a point 186 feet North of Irongate Drive, be and the same is hereby deleted and removed from the improvement described in Resolution No. 34-76 of this Council, duly adopted August 16, 1976, and it is hereby determined to proceed with the balance of said improvement in accordance with the provisions of said Resolution No. 34-76, except and to the extent aforesaid, and in accordance with the plans, specifications, profiles and estimate of cost heretofore filed with the Clerk of

Council and heretofore approved, but with such modifications thereto as shall be necessary and appropriate to evidence the deletion and removal hereinbefore ordained.

SECTION 2. That all claims for damages resulting therefrom, if any, that have been legally filed, shall be inquired into after completion of the proposed improvement, and the Municipal Attorney is hereby authorized and directed to institute legal proceedings in a court of competent jurisdiction to inquire into any claims that have been so filed.

SECTION 3. That portion of the cost provided in Resolution No. 34-76 to be assessed shall be assessed in the manner and the number of installments provided in said Resolution and on the lots and lands described therein, except the property described in SECTION 1 hereof.

SECTION 4. That the estimated assessments heretofore prepared and filed in the office of the Clerk of Council be and the same are hereby approved, but with such modifications thereto as shall be necessary and appropriate to reflect the deletion and removal of certain property described in SECTION 1 hereof from the improvement.

SECTION 5. The Clerk of Council is hereby directed to deliver a certified copy of this ordinance to the County Auditor within fifteen days after its adoption.

SECTION 6. Subject to the provisions of Ohio Revised Code Section 727.24, the Manager is hereby authorized and directed as soon as the funds therefor are available to make and execute a contract for said improvement with the

lowest and best bidder after advertising according to law and the improvement shall be financed as provided in Resolution No. 34-76.

SECTION 7. This Council hereby finds and determines that all formal actions relative to the adoption of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code.
