AN ORDINANCE AMENDING CHAPTER 957 OF THE MUNI-
CIPAL CODE RELATING TO CHANGES IN SERVICES AND
RATES.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

SECTION I

That Section 957.03d of the Municipal Code is hereby amended
as follows:

- d. Regular Residential Service: The pickup of normal household garbage and trash once per week at the [front building line] curb, except for those persons granted an exemption pursuant to the Rules and Regulations; service includes special pickups on call for household discards over fifty pounds or bulky items; includes brush pick up and/or chipping.

SECTION II

That Section 957.05a of the Municipal Code is hereby amended
as follows:

- a. The fee for residential refuse collection service shall be [Five Dollars and Fifty Cents (\$5.50)] Six Dollars (\$6.00) per month [.] ; provided, however, there shall be an additional charge of Five Dollars (\$5.00) for each special pickup and a charge of Five Dollars (\$5.00) for each one half hour of chipper service. The fee for regular residential refuse collection service shall be paid by all residential customers and the City may bill in advance for a quarter annual period. The City may bill for special pickups and chipper service following completion of the work and shall be paid by the customer within the period and subject to the provisions of subsection d. hereof.

SECTION III

This ordinance shall become effective from and after the earliest date allowed by law.

AN ORDINANCE AMENDING CHAPTER 957 OF THE MUNI-

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

SECTION I

The fee for regular residential refuse collection service shall be paid by all residential customers and the City may bill in advance for a quarter annual period. The City may bill for special pickups and chipper service following completion of the work and shall be paid by the customer within the period and subject to the provisions of subsection d. hereof.

SECTION III

This ordinance shall become effective from and after the earliest date allowed by law.
