AN EMERGENCY ORDINANCE PROHIBITING RIGHT TURNS ON RED TRAFFIC SIGNALS AT CERTAIN INTERSECTIONS.

WHEREAS, Section 4511.13 Ohio Revised Code effective July 1, 1975 permits local authorities by ordinance to prohibit right turns against a steady red signal at any intersection and provides for the posting of signs giving notice thereof; and

WHEREAS, said Section of the Revised Code of Ohio otherwise permits right turns against red traffic signals if same are not prohibited by the municipality; and

WHEREAS, the City of Centerville has made a study of all intersections within the City and has determined that it would be unsafe to permit right turns at certain intersections;

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. Pursuant to Section 4511.13 Ohio Revised Code, right turns against a steady red traffic signal are prohibited at the following intersections within the City of Centerville:

- A. Main Street (State Route 48) and Franklin Street and this prohibition shall apply to all drivers approaching the said intersection from every direction;
- B. Main Street (State Route 48) and East Alexandersville-Bellbrook Road and this prohibition shall apply only to westbound drivers on East Alexandersville-Bellbrook Road;
- C. North Main Street (State Route 48) and East Whipp Road and this prohibition shall apply only to northbound drivers on North Main Street;
- D. East Franklin Street and North Johanna Drive and this prohibition shall apply only to southbound drivers on North Johanna Drive;
- E. West Franklin Street and Virginia Avenue and this prohibition shall apply only to northbound drivers on Virginia Avenue;
- F. Far Hills Avenue and Loop Road and this prohibition shall apply only to westbound drivers on Loop Road.

Section 2. The City Manager is hereby authorized and directed to cause signs giving notice of the aforesaid prohibitions to be posted appropriately at said intersections.

Section 3. This ordinance shall become effective from and after the

earliest date allowed by law. Passed this 16th day of Jour , 1975.
