AN ORDINANCE AMENDING ORDINANCE NO. 15 DATED DECEMBER 11, 1961, THE ZONING ORDINANCE, BY RE-ZONING 82.134 ACRES, MORE OR LESS, FROM WASHINGTON TOWNSHIP R-4, CENTERVILLE B-2 AND CENTERVILLE I-1 CLASSIFICATIONS TO CENTERVILLE B-2, O-S, R-4, R-3, R-1 AND I-1 CLASSIFICATIONS

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. That the zoning map attached to Ordinance No. 15, passed on the 11th day of December 1961, and as subsequently amended, be, and the same hereby is, revised as follows:

Beginning at a point in the north line of said land conveyed to Joseph F. Rippe, trustee, said point being the following two courses from the northeast corner of said Section 14;

- South four degrees, forty-nine minutes, nineteen seconds West (S 4° 49' 19" W) with the centerline of Wilmington Pike for a distance of eight hundred sixty-eight and 53/100ths (868.53) feet to the northeast corner of said Joseph F. Rippe, trustee land;
- 2. North sixty-eight degrees, nine minutes, fortyfive seconds West (N 68° 09' 45" W) with the north line of said Joseph F. Rippe land, for a distance of one thousand five hundred one and 82/100ths (1,501.82) feet to the place of beginning.

Thence South one degree, fifty-nine minutes, fifty-three seconds East (S 1° 59' 53" E) for a distance of fifty and no/100ths (50.00) feet to a point;

Thence South sixty-six degrees, forty minutes, thirty-nine seconds West (S 66° 40' 39" W) for a distance of three hundred thirty and 2/100ths (330.02) feet to a point;

Thence North four degrees, forty-nine minutes, nineteen seconds East (N 4° 49' 19" E) for a distance of two hundred ninety-two and 29/100ths (292.29) feet to a point in the north line of said Joseph F. Rippe, trustee, land;

Thence, with the north line of said Joseph F. Rippe, trustee, land, South sixty-eight degrees, nine minutes, forty-five seconds East (S 68° 09' 45" E) for a distance of two hundred ninety-eight and 18/100ths (298.18) feet to the place of beginning, containing 1.134 acres, more or less.

Section 2. This ordinance shall become effective at the earliest date allowed by law.
