AN ORDINANCE AMENDING ORDINANCE 15-1961, THE ZONING ORDINANCE, SECTION 5 "DEFINITIONS" "PARKING AREA, PUBLIC" BY INCLUDING A MORE COMPREHENSIVE DEFINITION OF "HARD SURFACE".

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. Section 5, "Definitions" of Ordinance 15-1961 is hereby amended relative to Parking Area, Public, defined therein:

PARKING AREA, PUBLIC - An area, paved with a hard surface [in accordance with Village specifications] as hereafter defined, other than a street or alley, designed for use or used for the temporary parking of more than four motor vehicles when available for public use, whether free or for compensation, or as an accommodation for clients or customers. The term "hard surface" shall mean a surface constructed as follows:

- (a) One which has an aggregate base on all parking area (including aisles and passageways), 3" thick, in accordance with the "State of Ohio, Department of Transportation Construction and Material Specifications, January 1, 1973 item 304." which is incorporated herein by reference.
- (b) On said aggregate base shall be applied a Seal Coat MC-O or RT-2 A.E.S.P. at one-half gallon per square yard.
- (c) After application of said Seal Coat there shall be applied two 3/4" courses of asphalt concrete in accordance with said State of Ohio specifications, item 404.

All public parking areas shall be constructed as set forth above except that, upon application, the City Engineer may modify same in a proper case to provide as follows:

- (a) Provide a surface which has a stabilized crushed aggregate base, a minimum of 4" thick, in accordance with item 411 of said State of Ohio Specifications and
- (b) construction thereon of a wearing surface ("double seal") in accordance with item 409 of said State of Ohio Specifications.

 $\underline{\text{Section 2.}}$ This ordinance shall become effective from and after the earliest date allowed by law.
