AN ORDINANCE AMENDING ORDINANCE 10-69
BY RAISING THE SALARIES OF MEMBERS OF COUNCIL
TAKING OFFICE ON JANUARY 1, 1976 AND THEREAFTER.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. Ordinance 10-69 is hereby amended as follows:


Section 1. Beginning January 1, 1970, in accordance with Section 4.07, City Charter, each member of the City Council of Centerville, Ohio, shall be paid the sum of Ten (\$10.00) Dollars each regular, special or work session meeting attended by said member, not to exceed four (4) paid meetings per month [.] provided, however that with respect to those members of Council commencing new terms of office on January 1, 1976 and thereafter, each such member shall be paid as follows: An annual salary of \$3,300.00 payable in monthly installments of \$275.00. In the event any member shall not attend any regularly or specially scheduled council meeting and shall not be excused therefrom for valid reason, by vote of council, then the sum of \$50.00 for each such absence shall be deducted from the next succeeding salary installment payment to such council member. Provided, further that commencing January 1, 1977 and annually thereafter, said annual salary shall be adjusted upward or downward as follows: On said annual adjustment dates the annual salary provided for herein of \$3300 shall be divided by the Consumer Price Index for the United States based upon the year 1967 as determined for the month of January, 1976, by the Bureau of Labor Statistics of the United States Department of Commerce, and that figure shall then be multiplied by the same index as determined for the month of January of the year for which the adjustment is being made. From this resulting figure, the annual salary of \$3300 shall be subtracted and the remainder, if any, shall become additional salary for the next ensuing year beginning on January 1 of the said next ensuing year and one-twelfth of said additional salary shall be paid to each council member at the same time the monthly installment of the annual salary is paid.

If the aforesaid computation for the purpose of determining said additional salary results in a reduction by virtue of a lower price index for any year, the monthly installments for the whole of said year of said annual salary shall be reduced by an amount equal to one-twelfth (1/12) of the total resulting reduction for the year.

If the compilation and/or publication of such index shall be transferred to any other governmental department, bureau or agency or shall be discontinued the annual adjustment provided for herein shall terminate and, commencing with the January 1 next succeeding the date of such transferred or discontinuance, the annual salary for a council member shall be \$3300.00 payable in monthly installments as aforesaid.


Section 2. This ordinance shall become effective from and after the earliest date allowed by law.


