> AN EMERGENCY ORDINANCE ACCEPTING THE BID OF FRANK L. LUHN ASSOCIATES, INC. Section 2. This Ordinance is hereby declared to be an emergency measure and shall become effective immediately upon An emergency affecting public health, safety and welfare passage. is hereby declared to exist by virtue of the fact that the present Municipal Building is totally inadequate to serve the citizens of Centerville and provide the necessary service department with adequate quarters and furnishings and the best interests of the citizens of Centerville will only be served by the immediate completion of the new Municipal Building.
