> AN EMERGENCY ORDINANCE ACCEPTING THE BID OF DAYTON COMMUNICATIONS CORPORATION FOR THE INTERIOR FINISHING OR FURNISHINGS FOR THE CENTERVILLE MUNICIPAL BUILDING AND AUTHOR-IZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH SAID CONTRACTOR ON BEHALF OF THE CITY UPON THE POSTING OF THE PROPER PERFORMANCE BOND BY THE CONTRACTOR.

Section 1. The bid of Dayton Communications Corporation to supply Recording and Amplifying Equipment for the new Municipal Building for the City of Centerville which bid was for a total of Six Thousand Nine Hundred Fifty Two Dollars (\$6,952.00) for the base bid is hereby accepted and the City (\$6,952.00) for the base bid is hereby accepted and the City Manager is hereby authorized and directed to enter into a contract for the interior finishing or furnishings as set forth in said specifications in the form of contract set forth in said specifications upon the posting of the proper performance bond by said contractor in accordance with the said specification.

This Ordinance is hereby declared to be an Section 2. emergency measure and shall become effective immediately upon An emergency affecting public health, safety and welfare passage. is hereby declared to exist by virtue of the fact that the present Municipal Building is totally inadequate to serve the citizens of Centerville and provide the necessary service department with adequate quarters and furnishings and the best interests of the citizens of Centerville will only be served by the immediate completion of the new Municipal Building.
