ORDINANCE NO. 44-72 CITY OF CENTERVILLE, OHIO

Sponsored by Councilman Russell Sweetman on the 10th day of July, 1972.

AN ORDINANCE TO ADOPT THE OHIO BUILDING CODE BY REFERENCE AUTHORIZING THE CITY TO ENTER INTO A CONTRACT WITH OTHER MUNICIPALITIES, COUNTIES, HEALTH DISTRICTS OR OTHER POLITICAL SUBDIVISIONS, PERSONS, FIRMS OR CORPORATIONS TO DO ITS PLANS APPROVAL AND INSPECTIONS, DESIGNATING A CHIEF ENFORCEMENT OFFICIAL AND ADOPTING INSPECTION FEES.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section I. The "Ohio Building Code" is hereby adopted by reference under the provisions of Section 5.06 of the Charter of the City of Centerville.

Section 2. The Building Department of the City of Centerville and the City Manager are hereby authorized to enter into contracts with other municipalities, counties, health districts or other political subdivisions, persons, firms or corporations to undertake plans approval and inspections for the City.

Section 3. The schedule of inspection fees attached hereto, marked Exhibit "A" and incorporated herein by reference are hereby adopted for use in connection with inspections and plans approval in the City of Centerville.

Section 4. The City Engineer and any other person designated by the Building Department in lieu of the City Engineer which person is an architect or professional engineer registered in the State of Ohio, having at least five (5) years experience in building construction and design or a person having at least ten (10) years experience in building construction, design or inspection is hereby designated as the Chief Enforcement Official of the City of Centerville.

Section 5. This ordinance shall become effective from and after the earliest date allowed by law.
