AN EMERGENCY ORDINANCE ACCEPTING THE BID OF STUDEBAKER ELECTRIC COMPANY FOR ELECTRICAL CONTRACT WORK IN THE CONSTRUCTION OF THE NEW CENTERVILLE MUNICIPAL BUILDING AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH SAID CONTRACTOR ON BEHALF OF THE CITY UPON THE POSTING OF THE PROPER PERFORMANCE BOND BY THE CONTRACTOR.

SECTION I. The bid of Studebaker Electric Company to be the electrical contractor on the proposed new Municipal Building for the City of Centerville which bid was for a total of Sixty Thousand Eight Hundred Ten Dollars (\$60.810) for the base bid is hereby accepted and the City Manager is hereby authorized and directed to enter into a contract for the construction work as set forth in said specifications in the form of contract set forth in said specifications upon the posting of the proper performance bond by said contractor in accordance with the said specification.

SECTION 2. This Ordinance is hereby declared to be an emergency measure and shall become effective immediately upon passage. An emergency affecting public health, safety and welfare is hereby declared to exist by virtue of the fact that the present Municipal Building is totally inadequate. to serve the citizens of Centerville and provide the necessary service departments with adequate quarters and the best interests of the citizens of Centerville will only be served by the immediate commencement of
