ORDINANCE NO. 65-72
CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMAN RUSSELL SWEETMAN ON THE 16th DAY OF OCTOBER, 1972.

AN EMERGENCY ORDINANCE ACCEPTING THE BID OF JERRY SEUBERT COMPANY FOR MECHANICAL CONTRACT WORK IN THE CONSTRUCTION OF THE NEW CENTERVILLE MUNICIPAL BUILDING AND RATIFYING THE ACTION OF THE CITY MANAGER IN EXECUTING A CONTRACT WITH SAID CONTRACTOR ON BEHALF OF THE CITY.

WHEREAS, the City advertised for bidders for the work of mechanical contractor for the construction of a new Municipal Building for the City of Centerville, pursuant to specifications prepared by the City; and

WHEREAS, Jerry Seubert Company was the lowest and best bidder; and

WHEREAS, Jerry Seubert Company has posted a performance bond as provided for in said specifications and in a form satisfactory to the City; and

WHEREAS, the City Manager has executed a contract with said contractor on behalf of the City for said mechanical work;

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. The bid of Jerry Seubert Company to be the mechanical contractor on the proposed new Municipal Building for the City of Centerville, which bid was for a total of Fifty-Four Thousand Two Hundred Thirty (\$54,230.00) Dollars for the base bid is hereby accepted and the action of the City Manager in executing a contract for said work with said Jerry Seubert Company is hereby ratified and adopted as the duly authorized actions of the City of Centerville.

Section 2. This Ordinance is hereby declared to be an emergency measure and shall become effective immediately upon passage. An emergency affecting public health, safety and welfare is hereby declared to exist by virtue of the fact that the present Municipal Building is totally inadequate to serve the citizens of Centerville and provide the necessary service departments with adequate quarters and the best interests of the citizens of Centerville will only be served by the immediate commencement of construction.
