OF FEBRUARY 1, 1971 FOR A TABLE OF ORGANIZATION,
PERSONNEL CLASSIFICATIONS, RATES OF PAY, AND REGULATIONS
FOR EMPLOYEES OF THE CITY OF CENTERVILLE, OHIO.
