ORDINANCE NO. 74-71 CITY OF CENTERVILLE, OHIO Sponsored by Councilman John Davis on the 4th day of October, 1971. AN EMERGENCY ORDINANCE TO AMEND ORDINANCE NO. 4-71 FOR A TABLE OF ORGANIZATION, PERSONNEL CLASSIFICATION, RATES OF PAY AND REGULATIONS FOR EMPLOYEES OF THE CITY OF CENTERVILLE, OHIO.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. That Section 1., Table of Organization of Ordinance 4-71 is hereby amended as follows:

B. Department of Public Safety - Division of Police

Table with 3 columns: Number Authorized, Title, Pay Grade. Rows include Chief of Police, Acting Police Lieutenant, Police Sergeant [s], Police Patrolmen I, II, III, and Police Dispatchers.

D. Department of Development - Building Division

Table with 3 columns: Number Authorized, Title, Pay Grade. Row includes Building, Street and Sidewalk Inspector [14] 15.

Section 2. This ordinance is hereby declared to be an emergency ordinance and shall take effect immediately upon passage. A public emergency affecting the safety and general welfare is hereby declared to exist by virtue of the fact that due to the resignation of the City Manager of the City of Centerville as of July 1, 1971 and the elevation of a present sergeant of Police to the position of Police Lieutenant with duties of overseeing the operation of the Police Department has occurred with council in caucus determining during the month of July that the Police Lieutenant should be compensated for additional duties resulting from increased responsibilities and by virtue of the fact that the illness of the City Engineer and his subsequent resignation has resulted in the duties of street and sidewalk inspection devolving upon the Building Inspector during the months of June and July necessitating the appointment of the Building Inspector as Building, Street and Sidewalk Inspector with additional compensation.
