ORDINANCE NO. 9-70

CITY OF CENTERVILLE, OHIO

AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. 39-69 BY DELETING THE NAME OF HUGH LAGEDROST AS A MEMBER OF THE PLANNING COMMISSION, APPOINTING BRUCE H. BAKER TO THE TERM VACATED BY HUGH LAGEDROST AND APPOINTING MARION LOEMKER TO THE TERM VACATED BY BRUCE H. BAKER.

WHEREAS, Hugh Lagedrost heretofore appointed to a 4 year term on the Planning Commission commencing June 5, 1969, has submitted his resignation therefrom, which resignation has been accepted; and

WHEREAS, Bruce H. Baker, heretofore appointed to a 2 year term on the Planning Commission commencing June 5, 1969, has submitted his resignation therefrom conditioned upon his appointment to the four year term vacated by Hugh Lagedrost:

NOW, THEREFORE

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. Ordinance No. 39-69, Section 1, Subsections 2 and 7, passed on June 16, 1969, are hereby amended as follows:

- 2. (Hugh Lagedrost) Bruce H. Baker to serve for a term of four years, commencing June 5, 1969.
 - 7. (Bruce H. Baker) Marion Loemker to serve for a term of two years commencing June 5, 1969.

Section 2. This Ordinance is hereby declared to be an emergency Ordinance and shall become effective immediately upon its adoption. A public emergency affecting health, safety and the public welfare is hereby declared to exist because of the fact that the City of Centerville is presently without full membership on the City Planning Commission and the appointment of a new member to serve thereon at the earliest possible date is essential in order that cases now pending may be processed.
