ORDINANCE NUMBER 16-70

AN EMERGENCY ORDINANCE TO ESTABLISH A PERSONNEL APPEALS BOARD, ADOPT PERSONNEL RULES AND REGULATIONS AND APPOINT MEMBERS TO THE BOARD.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

SECTION 1. In accordance with the provisions of Article X, Section 10.04 of the Centerville Charter, there is hereby established a Personnel Appeals Board consisting of three members and with the duties as prescribed in the Charter and as hereinafter provided.

SECTION 2. Attached hereto, incorporated herein and made a part hereof are Rules and Regulations dated March 16, 1970, of the said Personnel Appeals Board, which are hereby enacted.

SECTION 3. The following persons are hereby appointed to the said Personnel Appeals Board to serve for the term designated opposite each name:

John E. Riley is hereby appointed to serve for a three-year term to commence on January 1, 1970 and to end December 31, 1972.

David R. Leigh is hereby appointed to serve for a two-year term to commence on January 1, 1970 and to end December 31, 1971.

John K. Buehl is hereby appointed to serve for a one-year term to commence on January 1, 1970 and to end December 31, 1970.

SECTION 4. This ordinance is hereby declared to be an emergency ordinance and shall become effective immediately upon its adoption. A public emergency affecting the public health, safety and welfare is hereby declared to exist by reason that it is necessary to establish said Board and adopt rules and regulations for its operation in order to meet the requirements of Article XIII of the Centerville Charter.
