ORDINANCE NO. 17-70  
CITY OF CENTERVILLE

AN ORDINANCE TO VACATE AN ALLEY ELEVEN FEET MORE OR LESS IN WIDTH RUNNING EAST AND WEST BETWEEN IN-LOT EIGHT AND IN-LOT NUMBER NINE OF THE BENJAMIN ROBBINS PLAT.

WHEREAS, on the 2nd day of March, 1970, a Petition by persons owning lots in the immediate vicinity of an alley eleven (11) feet more or less in width running east and west between in-lot number 8 and in-lot number 9 of the Benjamin Robbins Plat was duly presented to Council praying that said alley for its full length, be vacated; and

WHEREAS, said Petition was presented in accordance with the provisions of Section 723.04 of the Ohio Revised Code, and

WHEREAS, said Petition was signed by all of the owners of lots adjoining said alley thus eliminating the need for the publication of notice of the Council's intention to vacate in accordance with Section 723.07 of the Ohio Revised Code, and

WHEREAS, Council, upon hearing, is satisfied that there is good cause for such vacation as prayed for, that it will not be detrimental to the general interests, and ought to be made, now, therefore,

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

SECTION 1. That the following described alley to-wit:

Situate in the Village of Centerville, County of Montgomery, State of Ohio, and being the alley eleven feet more or less in width running east and west between in-lot number eight and in-lot number nine for the length thereof, of the Benjamin Robbins Plat of lots as described in Plat Book 1, page 11, of the Plat Records of said county, said plat also designated of record as "Plat of the Town of Centerville," recorded in Plat Book 1, page 11, of the Plat Records of Montgomery County, Ohio.

be and the same is hereby vacated.

SECTION 2. This ordinance shall become effective at the earliest date allowed by law.
