ORDINANCE NO. 29-70

CITY OF CENTERVILLE, OHIO

AN ORDINANCE AMENDING ORDINANCE 11-66 WHICH ENATED SECTION 36.31 OF THE CODE OF ORDINANCES OF THE VILLAGE OF CENTERVILLE, OHIO, BY ADDING DEFINITIONS AND CHANGING THE NOTICE PROCEDURE BY PROVIDING FOR AN ORDER TO REMOVE, A TIME FOR COMPLIANCE AND FOR IMPOUNDING.

SECTION 1. Ordinance 11-66 enacting Section 36.31 of the Code of Ordinances of the Village of Centerville, Ohio, is hereby amended by adding the following definitions to those set forth in said Ordinance:

Reconditioning - reconditioning is the process of restoring, refurbishing or repairing of a motor vehicle which must be performed in an enclosed area.

Unenclosed Areas and Unenclosed - unenclosed areas and unenclosed when used herein refer to areas not enclosed by a building with walls through which one cannot see or a fence through which one cannot see.

SECTION 2. That portion of Ordinance 11-66 enacting Section 36.31 of the Code of Ordinances of the Village of Centerville, Ohio, concerning Enforcement is hereby amended as follows:

Any person violating the provisions of this Ordinance shall, within [~~thirty (30)~~] seven (7) days after notification of said violation by a person acting on behalf of the [Village] City of Centerville, remove or cause to be removed any junk, junk cars, or rubbish or have the same placed in an [adequate enclosure or building] enclosure or building with walls or fencing through which one cannot see; and in the event of failure, within said [~~thirty (30)~~] seven (7) day period, to comply with said notice, he shall be deemed guilty of violating the provisions of this Ordinance.

SECTION 3. That said Ordinance 11-66 is further amended by adding the following section.

The City Manager or anyone designated by him is hereby authorized to remove or have removed any junk car left at any place within the City which is in violation of this Ordinance. Such junk car shall be impounded until lawfully claimed or disposed of in accordance with Chapter 737, Ohio Revised Code.

SECTION 4. Any ordinances, resolutions or parts thereof, in conflict herewith are hereby rescinded and repealed.

SECTION 5. This Ordinance shall become effective at the earliest date allowed by law.
