ORDINANCE NO. 9-69

AN ORDINANCE TO ADOPT THE UNIFORM BUILDING CODE OF MONTGOMERY COUNTY, OHIO, AS AMENDED, BY REFERENCE, UNDER THE PROVISIONS OF SECTION 5.06 CITY CHARTER AND ADOPTING INSPECTION FEES.

WHEREAS, it is necessary to provide for the proper regulation of building construction, remodelling and repair; the proper regulation of air conditioning and electrical installations; and, the proper regulation of heating and plumbing installations, for the public health, safety and welfare, now, therefore,

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. The Uniform Building Code of Montgomery County, Ohio, dated February 11, 1957, and as amended, February 25, 1960 effective March 8, 1960, is hereby adopted by reference under the provisions of Section 5.06, City Charter.

Section 2. Inspection fees shall correspond to Article 21, Permits, Inspections, Certificates, and Fees, Uniform Code, except Article 2101.04, Certificate of Use and Occupancy, is omitted from the above schedule. Permits Fees for a Certificate of Use and Occupancy shall be determined by Section 25B, Ordinance 1961-15.

Section 3. Sections 2 and 3 of Ordinance 1940-10 are hereby repealed; Section 53 of Ordinance 1943-5 is hereby repealed; and Ordinance 1958-16 and 1958-17 are hereby repealed.

Section 4. This ordinance shall become effective from and after the earliest date allowed by law.
