ORDINANCE NO. 35-69

AN ORDINANCE AMENDING ORDINANCE NO. 13-69, AN ORDINANCE DEFINING PROCEDURE FOR COMPETITIVE BIDDING.

THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. Section 1 (B) of said Ordinance No. 13-69 is hereby amended as follows:

"When an expenditure for any purpose mentioned in subsection (A) herein exceeds One Thousand Five Hundred Dollars (\$1,500.00), the Council shall, by ordinance or resolution, authorize and direct the City Manager to make such expenditure, take bids and make and execute all necessary contracts according to the procedure hereafter set forth."

Section 2. This ordinance shall take effect at the earliest time allowed by law.
