Mayor Compton called the meeting to order at 5:30 P.M.

Chief Matt Brown provided an annual update for the Police Department highlighting the following items:

- Restructuring the Police Department Organizational Chart
- Addition of a Records Specialist
- Addition of a 3<sup>rd</sup> School Resource Officer
- Social Media Committee
- Chaplain Program
- TCSU Peer Support Program
- Healthy Heroes Initiative partnered with Miami Valley Hospital
- Successful negotiation for the Police Union
- Information Technology Committee
- Health Insurance Committee

Assistant City Manager Mariah Vogelgesang provided information on the Community Cat initiative following the community meeting that was held on May 30, 2019. Neighborhood residents have volunteered to participate in the TNR program. If Centerville participates in the initiative, revisions to the Ordinance will be required to prohibit "reckless" feeding of animals rather than a general prohibition that currently exists. Discussion was tabled with the arrival of the Planning Commission members. Chief Matt Brown left the meeting at this time.

The grant application site visit and resubmission for the Cornerstone Park was reviewed. Mariah Vogelgesang provided a Cornerstone Status Update Memorandum which was shared with Council, Staff and Planning Commission. Timelines for the Preliminary Development Plan, Rezoning, Record Plats 1B and 7B, and Major Site Plans for JA Murphy, the Park and Treplus were reviewed.

At 7:25 P.M. Council moved to JV Stone Council Chambers for a regular meeting and will reconvene after the regular meeting.

At 9:15 P.M. Council reconvened in Executive Session for property as voted upon in the regular meeting. Mr. Palcher, Rory Garrity and Jim Brinegar were not present at this time.

At 9:50 P.M. after no official business was conducted, Mrs. Rau made a motion to move out of Executive Session, Mr. Engert seconded the motion, and it passed with a 5-0 roll call vote.

The Community Cat discussion resumed and Council concurred to participate in the Community Cat initiative and requested periodic reports regarding the program's success.

At 10:05 P.M., the meeting was adjourned. The next work meeting will be held on Monday, July 1, 2019 at 6:30 P.M. in the Kingseed Law Library prior to the regular meeting set for 7:30 P.M.
