Mayor Compton called the meeting to order at 6:40 P.M. Deputy-Mayor Belinda Kenley was excused from the work session due to a work commitment.

Doug Spitler and Andrew Rodney presented information on the Right Of Way Reservation Plan. The passage of ORC Article 4939.0314 (G) generated the need for a Resolution to designate areas where utilities are currently buried outside of the right of way. This Resolution is scheduled for Council vote at the June 18th meeting and will include both Cornerstone North and South.

Mr. Hudson provided information on the status of Tax Increment Financing at Cornerstone and Miami Valley Hospital South. He discussed the projections with full build outs and progressions.

The Memorandum of Understanding for Happy Meadows at Cornerstone and the related development agreement were reviewed with Mr. Liberman. A discussion was held regarding different options for the guaranty bonding for Happy Meadows. Happy Meadows offered to put up an annual letter of credit or place 50% of the funds (approximately \$1.8M) in an escrow account. Council concurred that they would prefer the full amount to be placed in escrow.

At approximately 8:00 P.M., after Mrs. Gopman, Mr. Rodney and Mr. Brinegar left the meeting, Mr. Beals made a motion to move into Executive Session for Economic

Development and for Litigation to confer with the municipal attorney on pending or imminent litigation. Mr. Engert seconded the motion, and it passed with a 6-0 vote. After no official business was conducted, Mr. Serr made a motion to move out of Executive Session, which was seconded by Mr. Engert and passed with a 6-0 vote.

In City Manager/City Council Communications, Mr. Davis shared information on the following topics:
