Dr. Gresham made a motion to convene into Executive Session regarding Personnel and Litigation at 6:33 p.m. Mr. Beals seconded the motion. A roll call vote resulted in six ayes. At 8:00 p.m., after no official business was conducted Mrs. Kenley moved that Council adjourn out of Executive Session. Mr. Palcher seconded the motion. A roll call vote resulted in six ayes.

Mr. Horn introduced Paul Fallon via phone who discussed the results of the community satisfaction and funding survey. Mr. Fallon used a trained, professional staff to conduct over 300 telephone (landline, cell, VOIP) interviews with registered voter city residents from November 4-8. He found an exceptionally high number of respondents believe the city is headed in the right direction with a high level of trust and confidence in the city. He found that 93% of the respondents believe the city has an excellent quality of service overall, which is another high figure. With regards to funding, he found a very sensitive attitude toward property taxes with a less sensitive attitude toward income taxes. Overall, he believed the survey found that residents are very content with the quality of services but are complacent toward additional funding. Council members discussed the survey results and funding strategies including income taxes versus property taxes and timing of an additional request.

Mr. Compton announced the annual retreat would be Saturday, January 30 at Benham's Grove.

Mrs. Rau announced that training for elected officials sponsored by MVCC would be Wednesday, February 3.
