Mayor Kingseed thanked them for volunteering to participate.

Mayor Kingseed noted the following in the Mayor's report:

The post office on Maple Street is closing on May 27; the post office on Paragon Road will then be the closest one for Centerville residents.

The Second Court of Appeals in Greene County recently rendered a negative decision on Centerville's right to use TIF financing for the development of the Dille property at Wilmington and I-675. Plans for a quality development at Wilmington Pike and I-675 are going forward.

The governor's biennial budget for the State of Ohio shows a cut of 25% in Local Government Funding for this year and the loss of an additional 25% next year. These cuts would be significant for the City of Centerville. If the budget is passed with these measures intact, the City will need to scale back some day-to-day services in order to balance the budget.

Dr. Gresham read aloud a proclamation naming April 21, 2011, as "Arbor Day" in the City of Centerville. Third graders will be helping to plant trees in the median on Rahn Road.

Before reading aloud the proclamation regarding Clean Sweep Week in Centerville, Mr. Compton thanked the Public Works Department for its efforts in keeping the City safe, clean and attractive. Residents were urged to clean their properties and take advantage of the special pickups of large items on regular refuse collection days from May 2-5, 2011.

Mr. Horn noted the following in the City Manager's Report:

He noted that Virginia Hess not only donated hundreds of hours in creating the bas relief artwork for the Police Headquarters, but she also provided considerable funding in order to have the bronze casting done.

Mr. Horn commended the Montgomery County Water Department for the smooth operation to date of the replacement of the water lines on State Route 48 south of downtown. Traffic has been maintained at this point and has been flowing well most of the day. The County plans to have the construction done by the Americana Festival in early July.

Mrs. Wilder outlined code violations and resolutions for the month of March 2011, and presented the community calendar for April and May. She noted that the John P. Kalaman Memorial Blood Drive will be held at Police Headquarters from 9 a.m. to 5 p.m. on Wednesday, April 27, 2010. Since 1998, over 3,000 units of blood have been donated from this annual event. She gave details on the citywide garage sale on April 28, 29 and 30

and the special refuse collection the first week of May. Mrs. Wilder noted Yankee Trace golf and dining events, Arts Commission activities, Operation Clean Sweep in Centerville, the Great American Cleanup sponsored by Montgomery County and openings on the City's boards and commissions.

In standing committee reports, Dr. Gresham pointed out that prescription drug discount cards are available through the City of Centerville, the National League of Cities and CVS. Cards may be picked up at the Municipal Building or downloaded from the website. Dr. Gresham gave the basics of the program and noted that savings can average twenty-three percent for those without other insurance.

Mrs. Kenley, as Council's liaison to the library, on April 16 attended the opening of Hoot Trail at Grant Park. The trail, with funding by the library, the Yeck family and the Park District, has boards which provide a storyline geared to children aged three to eight. The Centerville Library is having its first book sale on April 30, 2011.

Mr. Cline, Council's liaison to the South Suburban Drug and Alcohol Awareness Coalition, reminded the public that prom nights are coming up, and he encouraged all parents to discuss the dangers of drinking and driving with their high school students.

Mayor Kingseed explained that the Consent Agenda contains procedural and administrative matters. The items are considered to be routine and are handled as a group with only one motion being made. Councilmembers took turns reading the Consent Agenda items into the record, before Mr. Beals sponsored the following Consent Agenda items and moved that they be approved:

### PUBLIC HEARING: ORDINANCE NUMBER 05-11 TO REZONE PROPERTIES ALONG CENTERVILLE BUSINESS PARKWAY FROM I-PD TO O-PD

Mr. Cline moved to remove from the table Ordinance number 05-11, An Ordinance Amending Ordinance Number 14-08, Chapter 1216, The Unified Development Ordinance, To Rezone 29.83 Acres Of Land, More Or Less, Located Along Centerville Business Parkway And North of Clyo Road And Being Multiple Tracts Of Land, From I-PD, Industrial-Planned Development, to O-PD, Office-Planned Development. Mr. Compton seconded the motion. The motion passed with seven ayes. At the previous meeting Council tabled the matter in order to do more fact-finding. Since that time, Council toured the area in question. Council is waiting for one additional report. When asked, Mr. Horn stated that one month should be a sufficient amount of time for the information to be received and dispersed. Mr. Singer moved to table the matter until the Council meeting on May 16, 2011. Mr. Cline seconded the motion. The motion passed with seven ayes. Mayor Kingseed asked that the individuals who spoke on this matter at the March meeting be notified that the issue would be before Council in May.

# PUBLIC HEARING: ORDINANCE 07-11 TO AMEND THE UNIFIED DEVELOPMENT ORDINANCE

Mr. Feverston, City Planner, gave the staff report explaining this annual clean-up ordinance that clarifies issues raised in the past year concerning our rules, defines regulations so that they are consistent with the original intent, and makes the Unified Development Ordinance compliant with amendments to the Ohio Revised Code. At its January 25 meeting, Planning Commission reviewed the proposed changes, held a public hearing, and unanimously recommended approval of Ordinance 07-11. Mr. Feverston enumerated the some of the more substantive changes as follows:

- In the section concerning residence family home and residence group homes, changes make the Code compliant with state regulations which allow residential family homes as a permitted use in all residential zones; residence group homes are still a conditional use. The spacing rate is reduced from half a mile to 500 feet.
- An update to the Section on Temporary Garden Centers returns to the original intent of permitting spring bedding plant sales and fall or holiday items as separate temporary operations. The change limits the amount of time a temporary business can be open to 90 days and creates a 60 day gap between uses.
- A change regulates sign materials by establishing minimum criteria similar to what is in effect in the APD. Sign materials should be opaque and of significant substance to resist deterioration. Corrugated plastic is not considered to be sturdy enough for temporary signs.

- Beekeeping is defined as an agricultural use requiring a minimum of 5 acres. A section on this topic has been added.
- He explained other corrections, clarifications and table updates. subjects were building setbacks, minimum acreages for residential planned development and non-residential development, fence material and parking lot landscaping.

Council concurred to remove changes related to family residence and group residence homes from the Ordinance 7-11, to be considered separately at a later time. Mr. Cline moved to strike Section 9.05 (A, 5) and (A, 6). Dr. Gresham seconded the motion to strike. The motion passed with seven ayes.

Dr. Gresham asked if the section on signs applied to both temporary and permanent signs, particularly to election signs. Mr. Feverston replied that it would apply to all signs and clarified that the directives would apply to election signs. Following discussion, Dr. Gresham moved to strike Section 9.51 (D) Sign Standards, Paragraph 15 on sign materials from proposed Ordinance 07-11. Mrs. Kenley seconded the motion to delete the section on sign materials. The motion passed unanimously with seven ayes

Mr. Cline sponsored Ordinance Number 07-11, An Ordinance Amending Ordinance Number 14-08, The Unified Development Ordinance For The City Of Centerville, as modified, and moved for its approval. Mr. Compton seconded the motion. The motion passed with seven ayes.

Dr. Gresham made a motion for the Council to move to the Law Library for an Executive Session concerning Litigation and Personnel. Mr. Cline seconded the motion. The motion passed unanimously. At such time, after no official business was conducted, Dr. Gresham moved to close the Executive Session. Mr. Cline seconded the motion. The motion passed with seven ayes.

There being no further business, the meeting was adjourned.
