Mr. Cline moved that the minutes of the foregoing meetings be approved. Dr. Gresham seconded the motion. The motion passed unanimously with Mrs. Lienesch abstaining from the minutes of the Work Session on July 9, 2007.

Mayor Kingseed welcomed Carolyn Rice, Montgomery County Treasurer and a resident of 1135 Green Tree Drive, who gave an update on the activities of the Treasurer's Office in her second annual visit to Council. She explained that tax lien sales are an important tool enabling the office to collect \$18.7 million in delinquent property taxes. She explained that a change in property tax rules from the State of Ohio will reduce taxes for residents over sixty-five years of age or older or totally disabled without income restrictions through a homestead exemption. The construction of Miami Valley South Health Center is progressing. The ribbon cutting is scheduled for late September.

The City/Washington Township joint financial analysis is in progress. The group from the University of Toledo has done their interviews, has gathered information and is calculating the possible financial impact of further cooperative efforts.

Mr. Horn announced the following during his City Manager's Report:

He extended his congratulations and reiterated that Just SAAB of Dayton does an excellent job with the landscaping of its property and sets the bar high for other businesses in the community.

He read excerpts from a letter from the Commission on Accreditation for Law Enforcement Agencies, Inc., congratulating the Centerville Police Department as a flagship agency and offering the department the opportunity to have a display of its policies and procedures at the Montreal Conference. He noted that the Police Department has had national accreditation for fifteen years and undergoes the periodic renewal process.

Tricia Rapoch, our Benham's Grove Administrator, has tendered her resignation and will be going to Centerville High School to work with the student radio program.

Congratulations were expressed to the new officers in the Police Department and to Captain Robertson and Lieutenant Casey on their promotions.

John Miller, the Superintendent at Yankee Trace Golf Club since 1993, has also tendered his resignation. He is taking a position as the Agronomist for the LPGA tour. John Miller has been instrumental in the construction, expansion and maintenance of the golf course.

Mrs. Gopman outlined code violations and resolutions for the month of June, 2007, and presented the community calendar for the coming month.

Mr. Cline noted \$1500 had been raised by the Junior Optimist Club at Incarnation School for the benefit of Slidell, Louisiana. The City of Centerville is organizing a trip for hurricane relief that will be leaving Centerville on September 29 and returning on October 6, 2007. ORDINANCE NUMBER 8-07 AMENDING RENTAL INSPECTION REGULATIONS

The Public Hearing was held concerning Ordinance 8-07. Mr. Liberman stated that this ordinance defines and strengthens penalties for refusal of entry for rental unit inspections. The legislation states that the owner/operator is responsible for notifying renters of the inspections and defines the penalties for failure to comply with the request for entry. Additionally, a technical change adds that the penalties also apply to other sections of the rental inspection regulations. (Sections 840.01 to 840.03) Mrs. Lienesch sponsored Ordinance Number 8-07, An Ordinance Amending Chapter 840 To Further Clarify Section 840.02(B) And Enacting New Centerville Municipal Code Section 840.02(C) Entry To Inspection Refused And Section 840.99 Penalty To The Rental Unit Inspection Regulations, and moved that it be passed. Mr. Cline seconded the motion. The motion passed by unanimous vote.

ORDINANCE NUMBER 9-07 RENAMING MIAMI VALLEY DRIVE TO PREMIER DRIVE

The Public Hearing was held concerning Ordinance Number 9-07. Mr. Horn explained that Miami Valley South Health Center would like the name of its main entrance off Wilmington Pike to be "Miami Valley Drive." However, that name is already in use for a very short stub street on the west side of the Wendy's at the corner of Wilmington Pike and Clyo Road. No addresses are associated with this stub street. Staff is recommending that Council honor the request for the stub street to be renamed "Premier Drive" so that "Miami Valley Drive" would be available for the hospital entrance street. Mr. Cline asked if the construction was on schedule to open the additional lane on Wilmington Pike. Mr. Horn deferred to Mr. Spitler, the City Engineer, who stated that completion was originally scheduled for July 31, 2007. Some problems have pushed the date back to the middle or end of August, but the construction should be completed before the ribbon-cutting at the end of September. Mr. Compton sponsored Ordinance Number 9-07, An Ordinance Renaming Miami Valley Drive, A Public Dedicated Street In The City Of Centerville To Premier Drive, and moved that it be passed. Mrs. Lienesch seconded the motion. The ordinance passed by unanimous vote.

Mr. Corbin objected to the appearance of Mr. Koussa and asked to be excused. He left the meeting at this time. Mr. Joseph Koussa, 1537 Beavercreek Lane, Kettering, asked God to protect the American troops and bring them home safely.
