#### **EMERGENCY ORDINANCE 13-07 ADOPTING PUBLIC RECORDS POLICY**

Mr. Horn explained that House Bill 9 takes effect at the end of September and requires that each governmental entity have a public records policy. This ordinance updates the current policy to ensure compliance with the new legislation. Mrs. Lienesch asked whether the Public Records Commission was still in existence within the City of Centerville. Mr. Schlagheck answered in the affirmative and added that this ordinance addresses the new laws which govern availability of records to the public. Mr. Cline sponsored Emergency Ordinance No. 13-07, An Emergency Ordinance Adopting The City of Centerville Public Records Policy, and moved that it be passed. Dr. Gresham seconded the motion. The motion passed unanimously.

#### EMERGENCY ORDINANCE 14-07 AMENDING ORDINANCE 33-06 AND MAKING APPROPRIATIONS FOR FISCAL YEAR 2007.

Mr. Schlagheck noted that the appropriations for the year were originally set at the beginning of 2007. Throughout the course of the year it is necessary to adjust appropriations in various funds. This ordinance increases appropriations for the general fund, the special assessments improvements fund and the golf course expansion fund. The major decrease is for the capital improvements fund because we do not expect to award the bid for the new public works facility until 2008. Mr. Corbin sponsored Emergency Ordinance No. 14-07, An Emergency Ordinance To Amend Ordinance 33-06 To Make Appropriations For The Current Expenses And Other Expenditures Of The City Of Centerville, State Of Ohio, During The Fiscal Year Ended December 31, 2007, and moved that it be passed. Mr. Compton seconded the motion. The motion passed by unanimous vote.

There being no further business, the meeting was adjourned to complete the Work Session in the Law Library.
