Mr. Horn announced the following during his City Manager's Report:

Appreciation was expressed to the Public Works Department for all of their efforts so far this year with regard to snow removal.

The North Main Street Lighting from Loop Road to Whipp Road is being installed this week. This is a cooperative project with Washington Township.

A wish was made for Marilyn McLaughlin to get well soon and to get back to enjoying her retirement. Marilyn was the Clerk for the City for 41 years and had recently retired. Recently she has had some health issues and is now recuperating at home.

Mrs. Kuschnerus outlined code violations and resolutions for the month of November, 2005, as well as the community calendar for the coming month.

Mr. Compton mentioned that the next Create the Vision Implementation Task Force Meeting will be held January 11th at the Fire Department Headquarters on McEwen Road.

Mayor Kingseed explained the Consent Agenda which contains procedural administrative matters. Approval of these issues will be as a group with one motion being made. ORDINANCE NUMBER 15-05 MUNICIPAL CODE OFFICIAL

The Public Hearing was held concerning Ordinance Number 15-05. Mrs. Wilder reported that this will allow the City's Code Official to serve a notice of violation to a resident that has a junk vehicle. This is a quicker method allowing the Code Official to serve the notice instead of going through a police officer or by certified mail. Mrs. Lienesch stated that Sande Heck, one of the City's Code Officials, had brought this to the attention of the Property Maintenance Code Task Force and Mrs. Wilder took action on this piece of legislation (to get it passed) so that there isn't a delay for residents who are trying to get the violations remedied. Mrs. Lienesch sponsored Ordinance Number 15-05, An Ordinance Amending Section 660.07 Of The Centerville Municipal Code To Allow The City's Code Official To Serve Notices of Violations, and moved that it be passed. Mr. Cline seconded the motion. The motion passed unanimously.

Mr. Bob Kyvik, 2555 Goodfield Point, requested the City of Centerville and the Township Trustees look at a study that was done nearly ten years ago; to see whether there would be any tax savings if Centerville and Washington Township were to merge into one entity. He has a copy of this study and has studied it closely. He is suggesting that a committee be formed to look into this matter and that he would like to serve on this committee. Mr. Cline commented on the Create the Vision Comprehensive Plan for the City and the Township that is currently being worked on. A merger study was not the intent - it was a long range comprehensive plan focusing on landuse and those types of things. A Joint Entities Committee was formed in the Spring of 2005 and the Committee's function is trying to find ways to be more efficient with tax dollars. Cooperative Savings is the goal, either by ordering processes or different functions that the two entities can share. There is a lot of energy going into that task. Again, it is not a merger study but the Committee is trying to find ways to be efficient with tax dollars. Mayor Kingseed acknowledged that Mr. Kyvik is challenging both public bodies to think about how to get those numbers from an unbiased source so that the information can be laid out in front of the taxpayers to find out if a merger would be beneficial.
