Kent Bristol, Executive Director, Miami Valley Communications Council, was present at this meeting to explain what energy aggregation could mean to residents of the City of Centerville. The State of Ohio Legislators decided to deregulate the energy industries primarily to serve as a device to create jobs and to make Ohio competitive with neighboring states in terms of energy costs. An issue has been placed on the May 6, 2003, election ballot to let the City act as the agent or broker on behalf of residents in the City of Centerville. Mayor Beals pointed out that what is being proposed is only enabling legislation; the City will only take action if it will benefit residents. Mr. Bristol advised that five of the eight Miami Valley Communications Council member cities have placed this issue on the election ballot. A video was shown explaining energy aggregation and promoting a favorable vote on May 6. Mr. Cline expressed appreciation to Mr. Bristol, on behalf of the Miami Valley Communications Council, for placing information relative to energy aggregation and the Centerville/Washington Township Joint Long Range Comprehensive Plan on cable TV.

HR 1345 on the Federal level, the Equity for Reservist Pay Act of 2003 proposes that anyone called to active duty for more than 30 days shall be paid the difference between his active duty pay and his current salary.

Miss Gilleland outlined code violations and resolutions for the month of March, 2003, as well as the community calendar for the coming month.

FARMLAND IN AGRICULTURAL DISTRICT SMITH PROPERTY

The Public Hearing was held concerning an application to renew the placement of farmland in an Agricultural District. Miss Gilleland described the subject property, being 37.072 acres belonging to Victor W. and Mary J. Smith at 2230 East Centerville Station Road. Approval of this application exempts land which is currently being farmed from special assessments being levied against the property, such as sewer, water and electric. Mr. Cline moved that the application to renew the placement of farmland in an Agricultural District for property owned by Victor W. and Mary J. Smith be approved. Mrs. Lienesch seconded the motion. The motion passed unanimously.

ORDINANCE NUMBER 09-03 ZONING ORDINANCE AMENDMENT CENTERVILLE STORAGE INNS OF AMERICA REZONING

The Public Hearing was held concerning Ordinance Number 09-03. Mr. Feverston reviewed this Rezoning Request filed by Thomas Smith for Centerville Storage Inns of America; a change of 0.109 acres of land from B-PD, Business-Planned Development to I-PD, Industrial-Planned Development. Mr. Feverston located the subject property on a map being situated at 1881 South Metro Drive. This is the southeast corner of a 3.542 acre tract that is currently zoned I-PD. The Planning Commission, by unanimous vote, recommended approval of this rezoning to City Council. Dr. Gresham sponsored Ordinance Number 09-03, An Ordinance Amending Ordinance Number 11-86 Dated July 21,1986, The Zoning Ordinance By Rezoning 0.109 Acres, More Or Less, From Centerville B-PD, Business-Planned Development To I-PD, Industrial-Planned Development, and moved that it be passed. Mr. Kingseed seconded the motion. The motion passed by unanimous vote.

ORDINANCE NUMBER 08-03 ZONING ORDINANCE AMENDMENT SIGNS

The Public Hearing was held concerning Ordinance Number 08-03. Mr. Feverston reviewed this proposed Ordinance which provides the opportunity for a business to exchange ground sign allowances to a wall sign with restrictions. The wall sign may not face a residential area or a roadway that is less than an eighty-two foot right-of-way. Mr. Feverston advised that negative remarks have not been received from businesses relative to this Ordinance. Mr. Cline sponsored Ordinance Number 08-03, An Ordinance Amending Ordinance No. 11-86, The Zoning Ordinance Of The City of Centerville, Ohio To Amend Section 23, The Sign Section Of The Zoning Ordinance In Accordance With The Provisions Of Chapter 713 Of The Ohio Revised Code, and moved that it be passed. Dr. Gresham seconded the motion. The motion passed unanimously.

ORDINANCE NUMBER 10-03 PERMIT FEES

The Public Hearing was held concerning Ordinance Number 10-03. Miss Gilleland reviewed this proposed Ordinance which increases some of the City's building inspection permit fees. These fees have not been increased since 1993. Through a survey of area municipalities by Miss Gilleland, it was found that Centerville's current fees are lower than most areas. The

proposed fee schedule has been reviewed with the Home Builders Association of Dayton and the Miami Valley. Mr. Krass sponsored Ordinance Number 10-03, Ordinance Number 10-03, An Ordinance to Amend Ordinance Number 20-93, And Chapter 1442 "Permit Fees" In The Centerville Municipal Code, and moved that it be passed. Mrs. Lienesch seconded the motion. The motion passed by unanimous vote.

Upon question of Doug Galusha, 6381 Marshall Road, Mayor Beals explained that Work Sessions of Council are held on Monday evenings for the purpose of gathering information. Work Sessions are informal meetings open to the public; consensus may be taken of members of Council, but no action. Mayor Beals outlined the many reasons Work Sessions are held. Mr. Galusha asked that Work Session Agendas be placed on the web. Mr. Kingseed moved that Work Session Agendas be placed on the City's web site. Mrs. Lienesch seconded the motion. Miss Lightle reviewed a proposed agreement between the City of Centerville and Levin Porter Associates Inc. for architectural services connected with the interior renovation of the Centerville Municipal Building. Plans are for the City to go to bid in the next few weeks and that the restoration be completed by the end of 2003. Mr. Krass sponsored Resolution Number 12-03, A Resolution Ratifying The Action Taken By The City Manager, On Behalf Of The City Of Centerville To Enter Into An Agreement With Levin Porter Associates Inc., For Architectural Services Connected With The Interior Renovation Of The Centerville Municipal Building, and moved that it be passed. Dr. Gresham seconded the motion. The motion passed unanimously.

RESOLUTION NUMBER 13-03 CDBG PROJECT CITY HALL

Miss Gilleland explained three projects which have been submitted by the City of Centerville to Montgomery County for Community Development Block Grants:

handicap accessibility at City Hall, requested \$271,925.00 of a total project cost of \$440,000.00,

handicap accessibility in the Architectural Preservation District, requested \$54,329.00 of a total project cost of \$137,025.00,

handicap accessibility improvements in the Leonard E. Stubbs Memorial Park, requested \$56,000.00 of a total project cost of \$85,000.00.

Miss Gilleland summarized the improvements to be made in each case. Dr. Gresham sponsored Resolution Number 13-03, A Resolution Ratifying The Action Taken By The City Manager To Submit An Application To The Montgomery County Board Of Commissioners For A Community Development Block Grant To Provide Handicap Accessibility At City Hall, and moved that it be passed. RESOLUTION NUMBER 14-03 CDBG PROJECT AP DISTRICT

Mr. Cline sponsored Resolution Number 14-03, A Resolution Ratifying The Action Taken By The City Manager To Submit An Application To The Montgomery County Board Of Commissioners For A Community Development Block Grant To Provide Handicap Accessibility In The Architectural Preservation District, and moved that it be passed. Dr. Gresham seconded the motion. The motion passed unanimously.

Mrs. Lienesch sponsored Resolution Number 15-03, A Resolution Ratifying The Action Taken By The City Manager To Submit An Application To The Montgomery County Board Of Commissioners For A Community Development Block Grant To Provide Handicap Accessibility Improvements In Stubbs Park, and moved that it be passed. Mr. Kingseed seconded the motion. The motion passed by unanimous vote.

RESOLUTION NUMBER 16-03 GRANT FOR TREES TO OHIO DEPARTMENT OF NATURAL RESOURCES

Miss Lightle reviewed an application for a 50/50 matching grant to be submitted to the Ohio Department of Natural Resources for the purchase of evergreen trees to be planted as a barrier along the hiker/biker trail in the area of Paragon Road and Shawnee Trail. Upon question of Mrs. Lienesch, Mr. Horn explained where this project has been budgeted. Mr. Kingseed sponsored Resolution Number 16-03, A Resolution Authorizing The City Manager, On Behalf Of The City Of Centerville, Ohio, To File An Application And Enter Into An Agreement With The Ohio Department Of Natural Resources For The Purpose Of Acquiring Funds Through The Division Of Forestry's Urban Forestry Assistance Program, and moved that it be passed. Dr. Gresham seconded the motion. The motion passed unanimously.

RESOLUTION NUMBER 17-03 SOUTH MAIN STORM SEWER IMPROVEMENT

Mrs. Pence advised that seven bids were received for the replacement of a failed storm sewer along the west side of South Main Street under the brick sidewalk. The project area is just south of West Franklin Street to Cranston Court. Mrs. Pence recommended that the bid submitted by TdM Construction Company in the amount of \$103,390.00 be accepted and that the City Manager be authorized to expend up to a total amount of \$131,390.00 in accordance with unit prices quoted in the bid in order to allow for contingencies found necessary during the construction process. This project is scheduled to begin almost immediately and to be completed June 26, 2003. Mr. Singer sponsored Resolution Number 17-03, A Resolution Accepting The Bid Submitted By The TdM Construction Company For The South Main Street Storm Sewer Improvement Project In The City Of Centerville And To Authorize The City Manager To Enter Into A Contract In Connection Therewith, and moved that it be passed. RESOLUTION NUMBER 18-03 STREET IMPROVEMENT PROJECT

Mrs. Pence advised that four bids were received for the 2003 Road Improvement Project, concrete repair and asphalt resurfacing. She recommended acceptance of the low bid submitted by the Shelly Company in the amount of \$712,547.50 and that the City Manager be authorized to expend up to \$750,000.00 in accordance with unit prices quoted in the bid in order to allow for contingencies found necessary during the construction project. The project includes curb repair, pavement repair, catch basin repair, storm sewer repair, underdrain installation and asphalt milling and resurfacing on seventeen asphalt street and four concrete streets. Pavement repairs are planned for East Franklin Street and Clyo Road. Mr. Cline sponsored Resolution Number 18-03, A Resolution Accepting The Bid Submitted By The Shelly Company For The 2003 Road Improvement Project, Concrete Repair And Asphalt Resurfacing In The City Of Centerville And To Authorize The City Manager To Enter Into A Contract In Connection Therewith, and moved that it be passed. Mr. Kingseed seconded the motion. The motion passed unanimously.

RESOLUTION NUMBER 19-03 DUMP TRUCKS

Mr. Horn advised that the purchase of two dump trucks were listed in the City's Capitol Program for the current year. He recommended that these trucks be purchased through the Department of Administrative Services, Office of State Purchasing from 32 Ford for a bid price of \$50,545.45. Necessary equipment will be mounted on these trucks after they have been received. Mr. Krass sponsored Resolution Number 19-03, A Resolution Authorizing The City Manager To Participate In A Contract With The Department Of Administrative Services, Office Of State Purchasing For The Purchase Of Two Dump Trucks For The City Of Centerville In Accordance With Ordinance Number 19-88, and moved that it be passed. Mr. Cline seconded the motion. The motion passed by unanimous vote.

RESOLUTION NUMBER 20-03 YANKEE TRACE SECTION 27 IMPROVEMENTS

Mr. Hoffman explained two change orders connected with Special Assessment Financing for Yankee Trace improvements, Section Twenty-seven which is now Section Twenty-six. This project includes the completion of the spine road connector and the Paragon Road roadway connection. All items covered by the change orders are in place. Great Traditions Land and Development Company has agreed to pay \$18,845.10 of the total \$82,527.60 charge. The total of SAF dollars for this project amounted to \$774,155.66. Mr. Cline sponsored Resolution Number 20-03, A Resolution Ratifying The Action Taken By The City Manager To Execute Payment For Change Order Number One, And Authorizing Payment For Change Order Number Two To Weigle Corporation To Close Out Costs Relative To The Yankee Trace Improvements Yankee Trace Section 27 Project, and moved that it be passed. Mr. Kingseed seconded the motion. The motion passed unanimously.

RESOLUTION NUMBER 21-03 GRAETER'S ICE CREAM

Mr. Pozzuto reviewed a Purchase and Sale Agreement between the City of Centerville and Hammerhead-Centerville LLC, known as Graeter's Ice Cream, for the purchase of property situated at the northeast corner of Main and Franklin Streets. Graeter's will purchase this property at 2 North Main Street for \$468,750.00 from Miami Valley Hospital. After the purchase and closing on the property by Graeter's, the City will purchase approximately 61% of the property for public parking and public right-of-way, for the sum of \$288,750.00. Mr. Pozzuto reviewed the site plan approved by the Board of Architectural Review, showed elevations of the proposed building and located the subject property on a map. City Barbecue will rent space from Graeter's for a new location in Centerville.

In answer to a question of Mr. Singer, Mr. Farquhar advised that in worst case scenario, and the property is for sale, the City has right of first refusal.

Maury Levine, representing Graeter's Ice Cream advised that Hammerhead-Centerville LLC is the company that holds the real estate and rents the location to Graeter's and City Barbecue.

Upon question of Mr. Singer, Mr. Schlagheck explained that money for this project has been encumbered out of the 2002 budget for land acquisition.

Mr. Kingseed and Dr. Gresham expressed appreciation to Mr. Pozzuto for completing this project for downtown Centerville.

Mr. Cline described this as one of the effects the Create the Vision Comprehensive Plan wishes to accomplish. People expressed the desire for a more vibrant downtown Centerville.

Mr. Krass sponsored Resolution Number 21-03, A Resolution Authorizing And Directing The City Manager To Enter Into An Agreement With Hammerhead-Centerville LLC To Purchase Real Property, and moved that it be passed. Mr. Cline seconded the motion. The motion passed by unanimous vote.

ORDINANCE NUMBER 12-03 RIGHT OF WAY

Miss Gilleland explained a proposed Ordinance to control utilities in the public right of way. There is a proliferation of utilities asking to use the City's right of way. The City needs input from the utility companies on the use of the right of way based upon their plans to serve Centerville residents and businesses. Utility companies have been involved in the preparation of this Ordinance. Miss Gilleland outlined components of the proposed legislation and listed the Municipalities which have passed similar Ordinances. Upon question of Mrs. Lienesch, Miss Gilleland advised that Centerville's proposed Ordinance is more lenient than that passed by some of the other Municipalities as well as the State Law. City Staff is comfortable with the fact that this legislation meets the needs and protects the City's right of way. Mrs. Lienesch moved that Ordinance Number 12-03, An Ordinance Adopting New Chapter 1080 Of The Centerville Municipal Code Regulating Activities Within The City's Rights Of Way, be set for Public Hearing on May 19, 2003. Dr. Gresham seconded the motion. The motion passed unanimously.
