Mr. Horn introduced the following Police Officers and recognized their recent accomplishments:

Police Officer Lynn Davis - retiring after 25 Years of Public Service.

Police Officer Greg Engelhard - Montgomery County Police Chiefs Association Officer of the year.

Chief of Police Steve Walker - Incoming President of the Montgomery County Police Chiefs Association.

Mayor Beals announced the following events which occurred during previous weeks: Bernie Young, Volunteer of the Year in 2000 has passed away. His many outstanding contributions to the City of Centerville were outlined.

January 11, 2001 was declared Nathan Ross Chapman Day in the City of Centerville. Nathan Chapman was a graduate of Centerville High School and was the first serviceman in the military to be killed by enemy fire. A fund has been established at the High School to benefit the Chapman children.

The General Motors Minority Dealers Association presented to the Bob Ross family the 2002 GMMDA Trailblazer of the Year Award in honor of Robert P. Ross, Sr., the former President of Bob Ross GMC.

Mayor Beals gave the "State Of The City" address outlining the events which took place in 2001, the many accomplishments made by the City of Centerville, as well as on-going projects in the City.

Mr. Horn supplied the following information during his City Manager's Report:

The widening project of Paragon Road is scheduled to begin the current week with utility installation across Paragon at The Golf Club at Yankee Trace.

Public Works Director interviews are continuing. An appointment is expected in mid-February.

The Open House for the new Centerville Police facility has been scheduled for March 17, 2002 from 1:00 P.M. to 5:00 P.M., with a formal dedication taking place at 2:00.

Mr. Horn expressed appreciation to Staff and to Council for their time spent on the preparation of the 2002 budget for the City of Centerville.

Miss Gilleland outlined code violations and resolutions for the month of December, 2001 as well as the community calendar for the coming month.

WATSON'S OF CINCINNATI CONDITIONAL USE REQUEST

The Public Hearing was held concerning a Conditional Use Request submitted by Donald Oeters for Watson's of Cincinnati to permit outdoor pool sales and display on a 7.467 acre parcel zoned Business-Planned Development. Mr. Feverston located the subject property on a map being situated south of Whipp Road and west of Wilmington Pike. This acreage is part of an overall Master Plan previously approved by City Council for this site. A one hundred foot buffer is required between this property and the property to the west. The outdoor storage will occupy 14,000 square feet. Landscape islands will meander between the pool displays. A secure

wrought iron fence will surround the display area. The Planning Commission by unanimous vote recommended approval of this Conditional Use to City Council.

Upon question of Mrs. Lienesch, Mr. Feverston advised that the parking requirement in accordance with the Zoning Ordinance has been satisfied, however it is excessive for this particular use. Mr. Horn suggested that perhaps the applicant apply for a parking variance in order to reduce the amount of asphalt.

Robert Treadon, Architect, expressed their willingness to work with the City for a parking variance for this use with the condition that if the property is sold in the future, the parking must be increased to conform to the requirements of the Zoning Ordinance.

In answer to a question of Mr. Singer, Mr. Feverston advised that twelve conditions have been placed on the Site Plan for this project by the Planning Commission. No conditions were recommended concerning the outdoor sales and display area.

Mr. Kingseed moved that the Conditional Use Request submitted for Watson's of Cincinnati for outdoor pool sales and display area be approved with the stipulation that Watson's work with the City of Centerville to obtain a Variance for a reduction of the parking area for this use only, and if the property is sold or used for a different use, the parking must be increased to conform with the parking requirements of the Centerville Zoning Ordinance.

ORDINANCE NUMBER 33-01 2001 APPROPRIATIONS

The Public Hearing was held concerning Ordinance Number 33-01. Mr. Schlagheck reviewed this proposed Ordinance to amend appropriations for the year 2001. The grand total appropriations for the year is \$32,485,520 which is approximately \$550,000 less than the original appropriations. Mr. Singer sponsored Ordinance Number 33-01, An Ordinance To Amend Ordinances 36-00 And 26-01 To Make Appropriations For The Current Expenses And Other Expenditures Of The City Of Centerville, State Of Ohio, During The Fiscal Year Ended December 31, 2001, and moved that it be passed. Mrs. Lienesch seconded the motion. The motion passed unanimously.

ORDINANCE NUMBER 35-01 2002 APPROPRIATIONS

The Public Hearing was held concerning Ordinance Number 35-01. Mr. Horn reviewed the 2002 Financial Plan for the City of Centerville. He outlined revenue sources and proposed expenditures with a \$30,601,750 grand total appropriation for the current year. Mr. Krass sponsored Ordinance Number 35-01, An Ordinance To Make Appropriations For The Current Expenses And Other Expenditures Of The City Of Centerville, State of Ohio, During The Fiscal Year Ended December 31, 2002, and moved that it be passed. ORDINANCE NUMBER 37-01 CITY PERSONNEL

Miss Gilleland outlined changes for the year 2002 to the Personnel Ordinances and Personnel Manuals for City employees and employees at Yankee Trace. The Ordinance provides a 3.5 percent increase for certain positions in the City. Mr. Kingseed sponsored Ordinance Number 37-01, An Ordinance To Repeal Ordinance Number 38-00 In Its Entirety And To Establish Class Titles, Pay Ranges, Grades, Rates Of Pay, And Regulations For Employees Of The City Of Centerville, Ohio, and moved that it be passed. Mrs. Lienesch seconded the motion. The motion passed unanimously.

He located the subject property on a map being situated at 5285 Wilmington Pike. The homestead includes a house, a barn and a milk house. The Board of Architectural Review has recommended approval of this application to City Council. Upon question of Mr. Singer, Mr. Feverston advised that the property owners, Loren and Virginia Gannon, are very supportive of this designation. ORDINANCE NUMBER 43-01 DESIGNATE LANDMARK JOHN ARCHER-ROBERT MCEWEN HOUSE

The Public Hearing was held concerning Ordinance Number 43-01. Mr. Feverston reviewed an application submitted by the City of Centerville to designate the John Archer-Robert McEwen House as a landmark. He located this house on a map being situated at 8661 Lebanon Pike and owned by Jack and Barbara Fritzsche. The Board of Architectural Review has recommended landmark designation of this house to City Council. Mr. Feverston pointed out that designating this house as a landmark does not affect the zoning of the property. If the land surrounding the house is developed, the house must be incorporated into the plan. The zoning of the property is R-PD, Residential-Planned Development which would provide a condominium or apartment development up to six units per acre. The house is one of Centerville's limestone houses. Upon question of Mr. Singer, Mr. Feverston advised that the owners are supportive of this house being designated as a historic landmark. Mrs. Lienesch questioned whether there was a property maintenance problem with this house. Mr. Singer sponsored Ordinance Number 43-01 An Ordinance To Designate The Building Located At 8661 Lebanon Pike And Known By Local Historians As The John Archer-Robert McEwen House, As A Landmark Within The City Of Centerville, Ohio, And Amending Ordinance No. 8-91, An Ordinance Establishing Procedures And Criteria To Designate Certain Houses, Buildings, Structures, Areas, Or Places As Landmarks Within The City Of Centerville, Ohio, And To Establish Procedures And Requirements To Regulate The Renovation, Rehabilitation, Remodeling, Addition, Alteration, Development, Construction, Or Demolition Of A Designated Landmark, and moved that it be passed. RESOLUTION NUMBER 5-02 PERCY PROPERTY

Mr. Horn advised that the City has attempted to acquire the property just west of the new Centerville Police facility but has not been successful. The single family home on the property is vacant. A Resolution has been prepared to appropriate this property at a fair market value. Mrs. Lienesch sponsored Resolution Number 7-02, A Resolution Authorizing The City Manager To Participate In A Contract With The Department Of Administrative Services, Office Of State Purchasing For The Purchase Of Several Vehicles For The City Of Centerville In Accordance With Ordinance Number 19-88, and moved that it be passed. Mr. Kingseed seconded the motion. The motion passed by unanimous vote.

RESOLUTION NUMBER 8-02 PUBLIC DEPOSITORY CORNERSTONE BANK
